PROMOTION STOCK AFFECTED BY DECISION

and before the company had any title to it or more than one-tenth of the purchase price paid; that the promoters in fact did no work on the ground but instead devoted their efforts to "support" the stock by means of wash sales and the like.

Judge Averill in his decision, used language which is of extreme importance. He said: "That the promoters of a corporation may receive for the property they secure and the trouble of the corporation. Their next step must be to sell that stock, if they sell at all, for a reasonable figure, very little above what it cost them, unless by their efforts and the expenditure of additional money they raise its value, or its value rises legitimately otherwise. If they create a treasury consisting of stock, 'treasury stock,' instead of their own money, they must use the proceeds of its sale for the development of the property; for otherwise that treasury stock can have no value above the value of the 'promotion stock.' It is enough for them to ask that outside money shall bear the burden of making the property more valuable for them and valuable enough to justify the price of the treasury stock. No greater burden should be imposed and none will be countenanced. If instead of treasury stock, assessments are levied, all stock should bear the burden alike, except when there are legal exemptions. The idea that the promoters can get out on 'silver' and get their stock for nothing at the expense of others, while making no effort to increase the value of the property, cannot be tolerated, because it means nothing less than fraud. Some brokers may call the proceeding hereindescribed a legitimate one, but a court can not be called upon to give countenance to it, and will not do so, and must brand it as fraudulent."

The amount of the note with the accrued interest almost offset the money paid for the stock. The decision is important for its effect upon mining promotions. The opinion is somewhat extended. Hatton & Hatton of Goldfield, were attorneys for the plaintiff, Pingree, and H. R. Cooke of Tonopah, was counsel for Miss Rullison.
