CASEMENT'S DEATH A MISTAKE

SIR ROGER CASEMENT has gone to meet his Maker and render an account of his stewardship on earth. With his soul purged of all evil and his end sanctified by the thought that he perished for the nobility. It made no difference in the end, but the English in his grave than in a dungeon. The victim of a mistaken conviction paid the penalty on the scaffold this morning when he was hanged with a common hempen rope instead of the silken cord used for the nobility. It made no difference in the end, but the English are such sticklers for the fetish of aristocracy that they insist on giving noblemen, born in purple, the prerogative of dying with a silk rope. Casement was a commoner by birth and elevated to the peerage as a recognition of his services to the state, therefore he was not entitled to the caressing folds of silk while strangling on the scaffold. The execution of Casement will always stand as a reproach to a government that has preached of its liberality and generosity until the name of Britain has come to be associated with thoughts of fair play. The penalty may have been deserved. Undoubtedly it was, for the crime was one of the most heinous in the political calendar, but expediency should have counseled a wiser course. With tens of thousands of Irishmen fighting at the front in France and tens of thousands more who gave their lives for the perpetuation of the Union Jack it would have been a more prudent policy to exercise clemency rather than exact the blood atonement. Ireland is entitled to better treatment than it has received at the hands of England. Promises of autonomy have been made repeatedly, only to be broken, and discrimination of the most odious character has been exercised between the subjects of the crown in the north and south of Ireland. The uprising at Dublin was a failure, but, as a political offense, it was not as aggravated as the uprising in the south of Ireland two years ago when Sir Edward Carson personally notified the British government that unless the Tories were permitted to drill and bear arms openly in defiance of the crown the whole British army establishment from Kitchener down would revolt. The Carson gentleman, instead of being summarily executed and dumped in the ditch, now stands as the uncanonized exemplar of loyalty and devotion, while the name of poor deluded Casement will ever be held up to scorn. Casement will be enshrined a martyr with the people and centuries hence the bards of Ireland will sing his praises in common with Wolfe Tone, Robert Emmet, Daniel O'Connell, Larkin and O'Brien.

WOMAN SHOWS THE WAY TO WILSON

HOLLAND issued an ultimatum to Germany with the result that the next day the kaiser was down on his marrowbones before the queen of the Netherlands, begging pardon and promising not to offend against her laws. In the course of one day the grievances of Holland were focalized in an ultimatum that evoked prompt compliance with her wishes. The United States has been two years whipping the devil around the stump in trying to exact obedience to the laws of humanity. The only result has been to call for an enlargement of the archives of the State department for the purpose of accommodating mountains of mail accumulated during the trying period when President Wilson was trying to devise some way out of the dilemma without offending the righteous majesty of any of the belligerent powers. Queen Wilhelmina not alone has a will, but she has the nerve to insist on her rights, as shown by the dispatches yesterday announcing officially that Germany had conceded every claim of Holland and that hereafter not a single Dutch ship would be molested under any circumstances.

With one letter the queen of Netherlands brought the German empire to book. A single declaration succeeded in doing what the United States, with its incomparable resources, failed to accomplish. President Wilson is opposed to suffrage, as he declares the political emancipation of women is a matter belonging to the several states and not a suitable subject for consideration of Congress or for the submission of a constitutional amendment. The example of Queen Wilhelmina should suggest a new train of thought which certainly is conveyed to the most obtuse intellect of the masses of Americans. If a woman could compel the kaiser to obey her wishes while the United States president was dilly dallying with "demands" it may be reasonably inferred that the woman in the case is superior to the man. Holland has a population of 5,200,000, while the United States boasts of something over 100,000,000 citizens, capable of eventually placing in the field an army of 20,000,000 soldiers. It is a shameful admission that a woman should be able to do what the boastful United States could not do and do it without any humiliation or sacrifice of dignity.

TENDERFOOT GUARDS

THE regular army of the military service may petition the War department to withdraw the aggregation of well meaning but temperamental young men from the extreme east who began seeing things of momentous import the moment they were put on sentry duty. These boys are chiefly metropolitan products who have been plunged into strange environment wherein everything is novel and weird. CORFU VALUABLE AS A NAVAL BASE

NO CHANCE OF THE FRENCH GIVING UP THE GATE OF ADRIATIC

(By Associated Press.)
CORFU, Greece, August 3.—The completion of the transport of the Serbian army from Corfu to Saloniki, according to allied naval officers on the island, by no means indicates that the allies are going to abandon the island. Corfu is too valuable as a naval base from which the exit from the Adriatic can be commanded. With the Italian naval base at Brindisi, the British base at Tarento and French bases at Corfu and Argostoli, the chances of Austrian or German vessels slipping into the Mediterranean from Pola or Durazzo are very small. It will be a long time before the French flag ceases to float from the walls of the ancient fortress overlooking the town of Corfu, or convalescent French sailors to bask in the sun on the warm terrace of the Emperor William's villa, the Achilleion.
