SELECT THE BEST QUALIFIED CANDIDATE

THE most sacred institution in this or any other state is its supreme court. The justices that sit upon the bench of the court of last resort in the commonwealth must be men of the best possible antecedents. They must have clean records, must command respect for their past as well as their present department. They must be learned in the law and not merely glib in its phraseology. They must be men who have equipped themselves through experience on the district bench if they are to render the people the quality of service that is their due.

You will note, by scanning the sample ballot, that the party affiliations of all candidates except those for supreme court justices are indicated on the ballots. There are no distinguishing marks following their names. It was only a matter of form that the various parties made their selections in the primaries. The intent of the law is that these officials shall be non-partisan.

This would remove from Socialists who vote straight tickets any objection to their casting their ballots for Hon. T. F. (Barney) Moran. To the dyed-in-the-wool Democrat the same condition applies. This gives the voter of the straight ticket an opportunity to cast his ballot for the best qualified man, who is indubitably Judge Moran, who is at present incumbent of the second judicial district bench, an office to which he has twice been elected.

SENATOR PITTMAN AND HIS BILL

THE Bonanza wishes to state plainly and forcibly that it has never even intimated that Senator Pittman had any ulterior motive in introducing the land bill. This paper does not insinuate that it was because of any prearrangement to enable a clique of cattle barons to obtain possession of the cream of the unappropriated lands of the state.

He undoubtedly thought it would be a popular measure and drew up the bill without giving thought to the fact that it would forever cut off from the state such federal aid, amounting to many millions of dollars, as has redeemed the desert of Churchill. He probably did not consider that it would put an eternal quietus upon home-steading, depriving poor people of their constitutional rights to acquire homes on public domain.

The friends of Senator Pittman should not be so eager to run to his defense, when his actuating principles have not been questioned by the opposition press, nor will any reputable Republican newspapers question them even at the eleventh hour. No, the Pittman land bill is simply condemned on its merits, or, rather, its demerits, and they are manifold and palpable.

VOTE FOR "OUR" CONGRESSMAN

THERE does not appear at this time to be any question as to the re-election of Congressman E. E. Roberts by the largest majority he has ever received, but that should not cause his friends to cease to work for him on the eve of election. Congressman Roberts has proven such an excellent public servant that he is a profitable investment for the people. By people, the Bonanza doesn't mean Republicans alone, for "Ed" Roberts serves all. He is as willing and eager to take up a governmental matter for a Socialist or a Democrat as for one in his own party. This is due not merely to the man, but to the uniqueness of his situation. Nevada is the only state in the union with but a single representative in the lower house. He is the sole representative. In other states there are divided representations, so that party men can be called upon by partisans, but Roberts is OUR congressman, no matter what may be our political affiliation. It would be an act of appreciation to roll up for him a majority that would prove that he has the good will of the people of all the parties.

BLACK EYE FOR GOMPERS

SAMUEL GOMPERS' effort to deliver the vote of the American Federation of Labor has no terrors for those Republicans who have followed the course of Gompers' political experiments in the past. In fact, no sooner had Gompers issued his appeal to the federation of which he is president, to vote for Wilson, than the Building Trades Council, including 34 trades with a membership of approximately 165,000 wage earners, 75 per cent of whom are mechanics, adopted a resolution condemning the Wilson administration "for lack of sympathy with the American workmen," and appealing to the 1,500,000 voters who constitute the buildings trades department of the American Federation of Labor to "work and vote against the re-election of Woodrow Wilson." The building trades department constitutes more than half of the Federation of Labor. This appeal is one which will be of especial interest to railway workers as well, because the grounds on which it is based involve General George W. Goethals, whom President Wilson has just appointed head of the special commission on railway wages and conditions, created by the Adamson law. The resolution is based on the treatment of organized labor by General Goethals and the

present administration on the Panama canal zone. The building trades' appeal says: "Our several national organizations have vainly complained to the federal government through the war department that alien, ignorant, unskilled laborers are being employed in gradually increasing numbers in the mechanical division of our several trades at a wage of 50 per cent lower than the prevailing rate wage, which is generally recognized and agreed to by our competitive contractors."

The Democratic press of the state first denied that President Hendricks of the University of Nevada went to Washington to lobby for the Pittman land bill and now seeks to condone, even to approve of his action. They are simply dancing the Wilson hesitation waltz.
