## LET ACTION BE TAKEN AT ONCE

WHEN the Bonanza decried the methods that were being practiced by the executive and advisory powers of Nye county, whereby the rate of taxation was increased while valuations were raised, and at the same time no extraordinary cause arose for the expenditure of the taxpayers' hard earned money, the executives and their advisers lost no time in sending to another county for a Democratic judge—not insinuating that he belonged to the machine—and slapping the editor into jail.

Now comes a case where another person is endeavoring to decrease the "overhead" and administer the affairs of the county, at least so far as his office is concerned, with an intent, backed by capability, to save the people a good portion of the money that has been wasted and get better results. The selfsame machine resorted to low and criminal tactics in its endeavor to besmire the character of the candidate, using the wires to his former home. The correspondence, as published in the Bonanza, shows the scurrilous work to have been futile.

It develops that either the deputy to the district attorney, following up the wire of the United States district attorney, Wm. Woodburn, Jr., attempted to have the impression made that he was a United States official, or that his name was forged to the dispatch.

No matter which may have been the case, the fact remains that criminal prosecution is in order, either of Frank Dunn, or those who forged his name. This prosecution should be as immediate as was Mr. Booth's. It is imperative that the light shine on the case before election day, and in plenty of time to have the true facts disseminated about not only through the county, but the state. There has been dirty work, criminal work, done, and the punishment must fit the crime. The voters are entitled to know the truth before they cast their ballots.

## WHERE MR. MILLER WAS IN INTENTIONAL ERROR

GRANT MILLER is a convincing orator and has the commingled dignity and humor that attract his auditors, and the Bonanza must say that he made a very eloquent address here on the street Sunday, but this paper has one particular fault to find with him and it must express it before election, or it will be too late. Mr. Miller's views of the Pittman land bill are as fully endorsed by the Bonanza as they are by Mr. Platt, as well as by all good Socialists and Republicans, and the joshing he gave the Republican candidate, something about licking him nineteen times in court or such a matter, is received in good humor.

But the Socialist candidate went entirely too far when he passed over the most important issue of the campaign with a wave of his hand and a smile of deprecation. And that was the tariff.

Men and women of Tonopah, of Nye county, of Nevada, do you realize that the future prosperity, the very existence of this country, depends upon the immediate enactment of a law governing imports that will act as a veritable wall to withstand the flood of foreign made goods as soon as the war ends? All the women and children in the embattling countries have been trained to trades and professions. The men will return from the armies to add to the host of skilled employees. Poverty will beset all of Europe. It will become necessary to have more exports than imports in order to rehabilitate, and the United States will be drained of its wealth as a consequence, with our people working for the European wage scale in order to compete. It is a direful situation to face and one that can only be prevented by the election of a Republican president and a Republican congress in order that the tariff wall may be built. Mr. Miller said that the tariff did not affect the working people. It was pure buncombe, and Grant knew it when he said it.

## DRAWING TO A BITTER END

THE campaign is drawing to a close, to a bitter end, as it were, for certain acrimony have developed, not only in national, but in state, county and even township affairs. Mr. Wilson showed some pepperyness yesterday by saying that critics of the administration were talking about things on which they were not informed. Well, why aren't we informed? The United States government is a fabric built up by every citizen. It is an open corporation and we ought to get reports, daily if necessary.

Perhaps we don't know what we are talking about. Perhaps the information that is given out from the White House is not merely deficient in detail, but is misleading. Maybe the president is neither watching nor waiting. He may have exacted reprisals upon the dozen or more governments that Mexico has had since the slaughter, rapine and general outlawry, including wholesale theft, began. If he has done so, the people should know it.

Mr. Wilson grows more touchy every day as the people are becoming cognizant of his failure to meet the situation squarely and either act or quit watching. As it is, he has thus far simply

been in the capacity of an interested spectator at a bull fight. Whether or not he sent a "postscript" to the Lusitania note is not known, but ire has been aroused in the White House over interrogations regarding the reported missive.

The refusal of the president to support the Susan B. Anthony amendment and his sop to the women by saying he voted for state suffrage at Princeton, is another cause for bitter feeling in the executive office. But the dregs of the cup are not reached. It will be drained next Tuesday night.

Coming down to state matters, there is also great soreness of spirit manifested by Senator Pittman. He created the land bill and it has become a Frankenstein, rising up to haunt and defeat him. Republicans and Socialists are alike wrathful over the bill and it is getting only half hearted support from the Democratic organs, and usually then in the form of advertisements.

But one of the sorest of the sore is "Judge" Sanders. He said the women were "for him," and he said right. The school teachers are particularly "for him," and are still going for him, while they are not half as active in securing his defeat as are other people, and for just cause. Acrimonious is indeed a soft word to describe his mental condition and expressions.

There is all sorts of bitterness in the county campaign. It has been particularly engendered by the abortive attempt of the Democratic machine in Carson City, Reno and Tonopah to defeat the Republican candidate for sheriff and assessor by blackening his reputation. Why, even the real "chief deputy district attorney" found it necessary to come to Tonopah yesterday. Yes, the campaign is certainly drawing to a bitter end.

## TWO WEATHER RECORDS BROKEN IN OCTOBER

During the month of October, according to the report by H. Legler, the local observer for the United States weather bureau, Tonopah enjoyed 271 hours of sunshine, or 78 per cent of the possible amount. The mean temperature for the month was 46 degrees, which was the lowest on record for October. Another record was broken. The precipitation was 1.35 inches, the greatest that has fallen here during that month since the weather observatory was established in 1906.

The highest temperature was 59 degrees on the 17th and the lowest was 24 degrees on the 23d. There was six inches of snowfall during the month. The heaviest precipitation was .98 of an inch on the 2d. The prevailing direction of the wind during the month was from the west, and the total movement was 5587 miles. The greatest velocity, 31 miles an hour, was from the north-west on the 18th.
