

IDAHO ABOLISHES A BIG BUNCH OF TAX EATING STATE ATTACHES

(By Associated Press) BOISE, Idaho, March 31.—Forty-four Idaho state departments and offices went out of existence today and reorganization of the state government into nine divisions, each headed by a commissioner directly responsible to the governor, took place. A bill authorizing these changes was passed by the recent legislature at the request of Governor H. W. Davis.

The nine commissioners will comprise a governor's cabinet, thus placing the chief executive central and control of the state's administrative civil offices, which heretofore had been loosely coordinated.

No attempt had been made by legislators in a creative new effort to modify the original scheme of government adopted at statehood to absorb the new changes without overlapping of responsibility and functions, so that the governor was being held responsible for administrative failures which he was powerless to prevent. It was agreed by the legislature.

SHORT LIVED MONARCHY DIES AFTER MONTH BIG EXPERIENCE

(Correspondence Associated Press) LISBON, March 3.—The monarchy established at Oporto and other points in the north of Portugal proved ephemeral. Barely a month after its proclamation an enthusiastic welcome a counter-revolution within the city, seconding the attack from outside by the republican troops sent by the government, succeeded with equal enthusiasm in restoring the republican flag on the spires and windows of Oporto.

GERMAN FAMINE BRINGS DISEASE

(By Associated Press) STOCKHOLM, March 1. (By Mail)—One request that America should send food to Germany was drawn up here by a delegation of medical scientists representing two hundred Swedish physicians who asked the American minister, Ira Nelson Morris, to forward it to President Wilson.

The petition was supported by the report of Professor J. E. Johanson, a nutrition expert, whose investigation of the German situation has been in progress since 1915. He declared that tuberculosis in Germany has increased 100 per cent. Basing his argument on this statement, the Swedish doctors in their petition said serious epidemics might be expected to spread through the world from Germany unless food was soon supplied to the German people.

Since the Swedish petition was presented to Mr. Morris, Germany has agreed to surrender her merchant ships to the allies and the latter have promised to send food to Germany.

Why should there not be a law on the books somewhere against charity grafting? The public should be protected against the thieves.

When elections in Germany are accompanied by riots the country would seem to be getting down to republican simplicity.
