DEATH OF CAPT. BOOTH

His float at half past today from the Elks Home where the late Captain Kenneth J. Booth passed so many happy hours surrounded with his beloved herd of Tonopah Judge No. 1982, R. P. O. E. of which he was an honored and old member. Signs of respect were shown from the courthouse and the olive flagstaff at the intersection of Main and Douglas avenues where the national colors drooped for the dead warrior.

The accompanying letter from Mrs. Frank L. Peterson, a change of address of Captain Kenneth J. Booth in 1917 by the University of Nevada, gives the first complete story of the loved and tragic sequel that was first mentioned in the Bonanza of Saturday. The letter was received in the widow at her home in Alameda.

OLDEST MIZPAH EMPLOYEE DEAD

Death called W. J. Williams, the oldest employe of the Tonopah Mining company Saturday from the home of Frank Maestri in Oakland where he was residing. Deceased was 82 years of age and came here from Astoria when news of the Tonopah mine went across the hills. For the last eight years he had acted as day watchman. Arriving in Tonopah with his wife and daughters, Mr. Williams entered the service of the Tonopah Mining company and remained in that employment until he finally compelled him to leave for a brief illness. He went on a trip to visit his daughters at Moscow, Idaho where he left after a short stay, looking to the independence of the mine and returned to the coast where he was a member of the Mason lodge in Oakland when the same name Deceased leaves a widow and two daughters, Mrs. Chas. Lander of Tonopah and Mrs. E. P. Hall of Moscow, Idaho.

Mrs. Williams was a member of the Knights of Pythias which he joined at Moscow, Ariz.

Mr. Williams was a familiar figure in Tonopah where he spent almost his holidays watching the coming and going of the tourists who drifted in and out of the camp and the boys of the Mizpah regarded him as the patriarch of the mine as most of them had entered the service as boys and grew into manhood under the kind observation of the gentle old watchman who was not known to have an enemy in the world. The first coming to Tonopah Mr. Williams was one of the best known residents of Astoria. It is probable that interest will take place at the county seat of Lander county, where so many friends of the family reside and where his parents are buried.
