REPUBLICAN STATE CENTRAL COMMITTEE VIRGINIA CITY, NEV. May 20, 1886. AT A MEETING OF THE REPUBLICAN STATE CENTRAL COMMITTEE of Nevada, held this day, it was resolved that a

REPUBLICAN STATE CONVENTION

CARSON CITY

-ON-

Friday, September 24, 1886.

At 1 o'clock p. m., For the purpose of nominating a full State ticket, viz: Member of Congress, Governor, Lieutenant Governor, Secretary of State, Justice of Supreme Court, Clerk of Supreme Court, Attorney General, State Controller, Surveyor General, Superintendent of Public Instruction, State Printer, Three Judges of the First Judicial District, The appointment of a State Central Committee, and the transaction of such other business as may properly come before the Convention.

The basis of representation to said Convention was made as follows: One delegate for each 50 votes, and one for each fraction of 25 or over, cast for the Blaine and Logan Electors at the last election, aggregating 144 Delegates, apportioned as follows: Churchill 2 Lincoln 4 Douglas 4 Lyon 7 Eureka 14 Sycamore 4 Humboldt 11 Ormsby 11 Storey 39 Washoe 14 Lander 11 White Pine 8

The several Republican County Central Committees of the State are hereby instructed to call primary elections of the people on

Saturday, September 11.

For the purpose of electing delegates to the said State Convention, the primary elections to be carried out in compliance with the laws of the State and the instructions of the Committee

The following test will be required of each and every voter at the said primary elections, viz: That he is a citizen of this State and will support the nominees of the Republican party at the coming election.
