THIRTEENTH SESSION

FIFTIETH DAY.

SENATE.

Senate met at 10:30 A. M. President Davis in the chair. Roll called, quorum present. Prayer by Rev. Van Deventer. Journal read and approved.

S. B. 63-An Act to provide for the maintenance and supervision of Public Schools. Bill provides for special elections in certain cases. Several amendments adopted and bill ordered re-engrossed.

By Westfield-S. B. 106-An Act consolidating certain county offices in the State of Nevada, and fixing the salaries of the officers thereof, and other matters pertaining thereto. [The bill refers to counties that have no more than 705 nor less than 685 voters.] Passed.

A. B. No. 84-An Act relating to maps of State and county boundaries. [Provides for the removal of all maps from office of Secretary of State to Surveyor General's office. Read third time and passed.]

S. B. No. 104-An Act to provide for the sanitary regulations in live stock of the State. Passed.

Senate Con. Res. No. 2-Relative to amending the Constitution of Nevada, by striking out the anti-lottery clause and submitting the same to the vote of the people in 1888. Passed-14 ayes, 4 nays.

AFTERNOON SESSION.

A. B. 69-Relative to Civil Court practice. Passed.

A. B. 12-To reduce poll tax to \$3. Passed.

A. Sub. for A. B. 31-Relative to Deputy Assessors. Passed.

S. B. 107-To refund to Commissioner Havenor monies expended at New Orleans. Appropriates \$3,971. Ways and Means.

A. B. 56-To facilitate giving of bonds. Passed.

Appropriation bill amended and ordered engrossed.

Senate adjourned till Wednesday, today being Washington's Birthday.

ASSEMBLY.

House called to order at 10:30 A. M. Speaker McDonell in the chair. Roll called, quorum present. Prayer by Rev. J. L. Woods. Journal read and approved.

MOTIONS AND RESOLUTIONS.

By Ford-Appropriating \$300 to Chief Clerk Fassett and Assistant Clerk Thomas for copying Journal of Assembly for State Printer. Resolution referred to Committee on Ways and Means.

By Griffin-Requesting State Land Register to furnish special Committee of Assembly a list of names of all persons who have applied for 640 acres of land. Resolution adopted.

INTRODUCTION AND FIRST READING.

By Fraser-A. B. 111; provides for an extra license of \$500 for three months for running burdy gurdy houses. Referred to Committee on Public Morals.

GENERAL FILE.

A. B. 78-An Act to create an Irrigation Committee. Referred to Committee of the Whole.

A. B. 75-Drury's measure providing for construction of canals and ditches for reclamation of lands.

The consideration of this bill evoked a lengthy discussion, Messrs. Craig and McConnell opposing the measure, and Williamson and Drury stoutly favoring.

Pending action on bill, Assembly took a recess until 1:30.

AFTERNOON SESSION.

Drury's Irrigation bill came up and after considerable discussion the enacting clause was stricken out.

A. B. 92, authorizing the purchase of maps. Amended and passed.

A. B. 72, for the maintenance of House of Refuge. Tabled.

A. B. 32, to abolish the office of Road Inspector. Passed.

A. B. 86, consolidating county offices. Senate amendment concurred in.

A. B. 68, made special order for Feb. 23 at 2:30 P. M.

On motion it was agreed to have all bills in the hands of committees reported by Feb. 26.

House adjourned till Feb. 23.

THE STATE LOTTERY.

A Characteristic Card from John Wood.

In 1868 the State of Louisiana authorized a State Lottery to increase the revenues of the State and prohibited the sale of foreign lottery tickets within the State. This lottery was started to keep the money at home. The capital stock was \$1,000,000 in \$100 shares. The proceeds of the lottery paid to the educational fund \$40,000 per annum. In 1879 the lottery agreed to pay \$40,000 per annum into the State Treasury. The law to give \$40,000 to the school fund was changed and the \$40,000 a year was given to the Charity Hospital of New Orleans. In 1895 this charter ends. The business of this institution has grown to nearly \$12,000,000 a year. It reaches every State and all conditions of society. Two ladies of one of the Carson churches called on me to get them \$5 worth of lottery tickets from New Orleans. It is no worse than raffling for a crazy quilt to support a church and better if you get a \$10,000 prize they said. There is one man in Carson that buys 500 of these lottery tickets a month and sometimes 700. He sends \$7,200 a year to New Orleans. For disposing of the tickets he gets 15 per cent. commission per month. There are other lottery agents in Carson. Washington and Jefferson when Presidents established the moral necessity by drawing lotteries for the benefit of the National capital, and the Supreme Court of the United States has established their legality.

I never saw anything take so well as the prospect of a lottery for the State of Nevada. One man said he sent \$20 to New Orleans every month. If there was a lottery in Nevada he would not send a dollar away. The new lottery means the creation of wealth, the lessening of crime, the cultivation of the best land in the State, the planting of forest trees and groves, the making of fish ponds and beautifying the landscape, new farms, fruit growing, fruit drying for export, the making of cheese and the curing of hams that now comes from the States of New York and Illinois. I hope that no false sentiment will oppose this grand scheme. Nevada has been kicked like a football and abused like a pick-pocket. Let us unite on this question and make a beginning for the benefit of the State and the unemployed. Any of us can give a dollar per month and never miss it and be the better off if we never draw a prize.

There is a gradual contraction of the currency. We are not earning our living for every man that works in this State, including the Indians, we have ten non-producers. We cannot sustain this undercurrent of our small means to go to New Orleans. Let the game and money be in our State. Is it possible that the State of Nevada with more undeveloped resources than any State in the Union shall become insolvent? The object and intent of government is to devise means to give employment. Amend the Constitution, pass the bill and it will be the means of keeping many a man out of the State Prison. All the State needs for the next 10 years is the ten commandments, water and a plow. At the end of that time we can fill the churches.
