SILVER OR WAR.

Some Red Hot Language in Colorado.

The big silver convention at Denver, was full of stirring incidents. Thos. Thomas the Democratic National Committeeman from Colorado, opened the meeting.

At the conclusion of Thomas' remarks there was a call for Governor Waite. The echo was taken up in a mighty shout from 1000 pairs of lungs, and was carried to the galleries, where as many more joined in the demonstration. As the old, gray-haired Governor started down the aisle to the platform the scene presented was beyond pen's description. Men whose future depended upon the cause for which they were fighting stood in their seats and yelled until exhausted.

The Executive, who comes from Aspen, one of the leading silver mining camps in this State, confined his remarks to the question of silver and its demonetization, and to those in the East and Europe who "were not only ready to ruin the West but the entire country by forcing such a policy," and concluded by saying, "If the money power shall attempt to sustain its usurpation by a strong hand, we will meet that issue when it is forced upon us, for it is indubitably better that blood should flow to the horses' bridles rather than that our national liberties should be destroyed. If it is true that the United States is unable to carry out its Governmental policy without dictation or consent of foreign powers: if we are a province of a European monarchy, then we need another revolution, another appeal to arms, and have won that battle."

A HINT OF WAR.

"If war is forced upon us we will send to Halifax a far greater army of British Tories according to our population than our forefathers sent there after the revolutionary war."

"War has begun. It is the same war which must always be waged against oppression and tyranny to preserve the liberties of man."

The address created a sensation, and a scene of great confusion followed, applause being deafening.

Judge Kerr of Pueblo got the floor and spoke in the same inflammatory vein as Governor Waite. He endorsed the recent revolutionary telegram sent East, in which it was declared that if the war upon silver continued it would result in the West repudiating all of her obligations; that 150,000 men would be paupers, that 500,000 people were on the verge of starvation, and that revolution would be the final result.

It was then moved that the convention endorse the remarks of Governor Waite. The motion was carried amid the greatest enthusiasm, and the convention adjourned.

IS JOHN SHERMAN DAFT?

A few days ago John Sherman, the man who sold out his country by smuggling the silver demonetization act through Congress, woke up and lost his temper because James H. Platt, of Denver, charged him with his corruption.

It's queer that Sherman, after being charged openly, over and over again, with this grave crime, in the papers, in the magazines, on the floor of the Senate chamber, and about everywhere else, should suddenly wake up and get mad when Platt, of Denver, makes an allusion to it.

Sherman's course in the matter has been so open and notorious, so brazen and so infamous, that there is not a school boy in America who does not know of his rascality.

He is the tool of the gold ring in the Senate, and he has defiantly worn their collar for years.

On \$5,000 a year, he has become a millionaire and has no other means of support than politics. In his old age, Sherman is losing his head, and his last show of temper has made him a laughing stock.

Perhaps he lost some of his wealth in one of those busted banks, which went to the wall under the ruinous financial system his trickery and greed has saddled upon the country.

Postmasters Appointed.

A Washington dispatch says: The records of the postoffice department show that during the first four months of the present administration the total number of presidential postmasters appointed is 434, as against 578 appointed during the first four months of Harrison's administration. As to the appointment of fourth class postmasters, the records show that during the first four months of the present administration there have been 5,730 made on resignations and deaths and 3,226 on removals, making a total of 8,956. The number appointed on resignations and deaths during a corresponding period in Harrison's administration was 3,649, and removals 7,460, making a total of 11,109.

The Comet.

A new comet is now visible in the north western sky. If you know where the polar star is and the constellation of the Great Bear, otherwise known as the big dipper, you will find the comet below Kappo, the lower star of the constellation.


