Facts About Centenary College.

The injunction suit involving Centenary College will take place in Clinton Louisiana on the fourth day of next September. This suit is to decide the legal question as to whether Centenary College can be moved from Jackson.

In 1825 the State of Louisiana established "The College of Louisiana" at Jackson, Louisiana. In 1845 the State sold this college at public auction. Judge Edward McGehee was the highest bidder. He bought the college, owned and managed it for three years. He changed its name to The Centenary College of Louisiana. He then appointed a board of trustees and turned the college over to them in trust—not in ownership. He vested the title to the college in this board. This board is self-perpetuating by electing members to fill vacancies as they occur.

Eight members of the Board believe that they have neither legal nor moral right to transfer the college in order that it may be moved. Judge McGehee made no provision for the removal of the college.

In December 1904, when the Louisiana Annual Conference met at Lake Charles, the board of trustees offered to transfer the college to the Conference on condition that the college remain where it is and as it is. The Conference refused to accept the college on such condition and passed a resolution stating that if the Board of Trustees refused to transfer the college without the above condition suit would be instituted and the Board be compelled to do so. The Conference appointed a committee to confer with the Progressive League of Shreveport. This committee entered into an illegal contract with the Shreveport League. In this contract Centenary was to be sold for about half its value and moved to Shreveport. To prevent this sacrifice of one of the grandest institutions of the South, the eight members of the Board of Trustees who believe that the college should remain where it was established by Judge McGehee, got out an injunction.

The matter will be tested in the courts on the fourth of next September.

Centenary will open on the thirteenth day of the coming September, notwithstanding the report scattered far and wide by some persons that Centenary will open no more in Jackson. For high Christian character and splendid class-work, Centenary has recently closed one of her most successful sessions. The prospects for the session 1905-6 are good. President Miller is in the field "hunting boys," and nearly every mail brings letters inquiring for terms and catalogues. Some of these inquiries come from the Pacific States, some from others who wish to avail themselves of the splendid co-educational opportunities now offered by this institution in both literary and commercial departments.

Centenary will stay in Jackson years yet, for it will take several years before the courts can give their decision even if they should decide that Centenary can be moved.

LAFAYETTE SELECTED.

Annual Reunion of the United Confederate Veterans to Be Held Here August 23 and 24.

Sons of Veterans Will Meet at Same Time. Railroad Rate of One Fare for Round Trip.

Lafayette has been selected as the scene of the forthcoming reunion of the Louisiana Division of the United Confederate veterans. These orders were issued Thursday:

Headquarters Louisiana Division, United Confederate Veterans, New Orleans, La., July 20, 1905. General Orders No. 5.

1. The Major General Commanding desires to inform the officers, Camps and ladies of the division, that the fifteenth annual State Convention and Reunion will be held at Lafayette, La., on Wednesday and Thursday, August 23 and 24, 1905.

2. A railroad rate of "One fare for the round trip," from all points in Louisiana has been secured. Tickets can be bought, and are good, going on August 22 and 23, and will be good for return up to Sunday, August 27, inclusive. This rate is open to the public generally, so that all who desire to visit Lafayette upon the occasion of our convention, are assured this cheap "round trip rate."

3. The United Sons of Confederate Veterans will hold their annual State convention at Lafayette upon the same date.

4. Every Camp of the Division is urged to appoint a sponsor, and as many maids of honor as they may choose, from eligible young ladies, who can be present at our State reunion. Those who are members of any of the ladies confederate organization in the State are eligible. The daughters and grand-daughters of Confederate soldiers are also eligible, even if they are not members of any Confederate organization.

5. The members of the committee on history are requested to send to the adjutant general the respective reports for which they have been detailed, in special orders No. 5, not later than August 13, in order that time for necessary compilation may be had. These reports constitute by far the most important business of the convention, and are secured at the cost of both time and labor, on the part of those comrades who patriotically prepare them.

6. All staff and camp officers are urged to endeavor to secure the largest possible attendance, not alone from the members of our organization, but also from among other veterans and the people generally, and especially the young of both sexes, who by attendance, may possibly be impressed with the fact that they should associate themselves with some of the Confederate organizations, and thus aid in perpetuating a true history of our country.

7. At this convention, a major general is to be selected to command the division for the ensuing year,—to enter upon his duties on the 5th day of November, 1905.
