





## OFFICIAL PROCEEDINGS OF THE POLICE JURY

Edgard, La., May 4th, 1922.

The Police Jury met this day in regular session with Hon. P. G. Songy in the Chair and the following members present: Messrs. Reynaud, Barre, Duhe and Bourgeois. Absent, Mr. Montegut.

The minutes of regular and special meetings held in April were read and on motion of Mr. Barre, seconded by Mr. Bourgeois and carried, said minutes were ordered approved as read. The report of the Finance Committee showing a total of \$1,278.20 drawn against the Bank of St. John, and \$767.11 drawn against the Bank of Edgard to pay salaries and bills incurred during April was read, and on motion of Mr. Reynaud, seconded by Mr. Duhe and carried, said report was ordered accepted, and said bills were ordered paid.

A communication from Mr. Cyrille Schexnaydre demanding the sum of \$250.00 from the Police Jury for the piece of his property to be used for road purposes at White Rose was read, and on motion of Mr. Barre, seconded by Mr. Duhe and carried, the secretary was authorized and directed to write Mr. Schexnaydre making a counter offer of \$100.00 for said piece of property, Mr. Schexnaydre's figures being entirely too high. A claim from Mrs. C. Schexnaydre for \$2.49 as refund for Special Good Road Taxes paid twice in the year 1919 was read, and on motion of Mr. Barre, seconded by Mr. Bourgeois and carried, said refund was ordered, and secretary was directed to issue a voucher accordingly.

On complaints of lack of drainage and the great number of dams along the public highways on both sides of the river, it was moved by Mr. Duhe, seconded by Mr. Reynaud and carried that the Sheriff be and is hereby directed to serve notice on all such property owners that such ditches along and leading from the public highways must be unobstructed, particularly in front of gates, violation of which act is a penal offense.

The bill of Godchaux Sugars Inc., for \$230.59 for 2 cars of gravel sold to the Parish in 1921 having failed to obtain the approval of the Finance Committee, due to said figures being in excess of gravel purchased from other concerns; it was moved by Mr. Duhe and seconded by Mr. Bourgeois and carried, that said bill be paid and that Mr. Duhe be authorized to obtain a refund on this amount if possible.

Mr. Zenon Montz and Mr. L. M. Reynaud representing the residents of the sixth ward appeared before the Police Jury with a request that some means be devised towards financing the purchase of sufficient gravel to gravel the Hopeville road, and on motion of Mr. Bourgeois, seconded by Mr. Duhe and carried, the secretary was authorized and directed to take this matter up with the District Attorney, it being the sense of the Police Jury that said road would be most beneficial to the residents of the sixth ward, as well as the neighboring wards, and that the said District Attorney be requested to give his advice as to the best means of financing this project.

On the Hammond-Ory-New Orleans project was deferred to a special meeting of the Police Jury to be held on Tuesday, May 9th, said meeting being called for this specific purpose.

There being insufficient funds on hand to meet the bills approved and to pay over to the School Board the sum of \$5,000.00 due said Board on the 1/2 mill on the 1921 taxes; it was moved by Mr. Duhe, seconded by Mr. Barre and carried that the President be and is hereby authorized to borrow from the Bank of St. John the sum of \$3,000.00, and from the Bank of Edgard, the sum of \$3,000.00 to meet said indebtedness, and the secretary and treasurer were directed to issue to the School Board, a voucher on Bank of St. John for \$3,200.00; and one on Bank of Edgard for \$1,800.00. There being no further business, on motion duly seconded and carried, the meeting adjourned.

## Official Proceedings OF THE School Board

Parish of St. John the Baptist

Edgard, La., April 11, 1922.

The School Board assembled this day in regular monthly session with President E. O. Abadie in the Chair and the following members present: Messrs. Millet, Bourgeois, Tassin and Gendron. Absent, Mr. Alexandre. Mr. Willie Gravois appeared before the Board in the interest of the Vacherie School and requested help the Board to erect a two-room school at Vacherie. The Board instructed the Superintendent to consult with Mr. Gravois and to purchase some second hand lumber for the erection of the school.

It was moved by Mr. Gendron, seconded by Mr. Tassin and carried, that Holy Thursday and Good Friday be declared holidays in this Parish. The Superintendent read a letter from Miss Boutton requesting that she be reimbursed the salary lost while she was ill. He explained that Miss Boutton had been allowed three days. The Board agreed that only three days should be allowed. The Superintendent reported that a test had been made on the Reserve High School boiler in the presence of Mr. Millet, Board Member of the Fifth Ward, and that the operation of the boiler was not satisfactory because three hours time was required firing every fifteen minutes, to raise a pressure of two pounds of steam. After consulting with the District Attorney the Board instructed the Superintendent to write a letter to C. C. Hartwell Co., explaining the reason why the boiler cannot be accepted by the Board.

The following bills were approved by the Finance Committee and on motion of Mr. Tassin, seconded by Mr. Gendron, and carried, they were ordered paid:
