New York, Sept. 8.—The police yesterday arrested James Morrissey on the charge of causing the death of Sunday last of James Kerrigan, during a quarrel between the two men in the New York Central freight yards.

Four Killed in Military Maneuvers. Vienna, Sept. 8.—During the Austrian military maneuvers yesterday on the borders of Galicia and Bohemia a big gun exploded, killing four men outright and fatally wounding 18 others.

A Veteran's Murderous Jealousy. New York, Sept. 8.—John Rieder, a veteran of the civil war, killed his wife and himself at their home in Brooklyn, yesterday. He was 63 years old, and his wife was 20 years younger. Jealousy was the cause of the double tragedy.

Canadian Pacific Strike Threatened. Winnipeg, Sept. 8.—A strike among Canadian Pacific conductors is considered almost certain. The company offered to reinstate the four men suspended, but they refused to work unless given pay for the time suspended.
