HARRINGTON AND CHAPMAN SIGN ARTICLES FOR BOUT

Wrestlers Will Meet at the Calumet Theater at Cornish Style One Week From Saturday—Rowett is Favored by Local Fans in Coming Match With Jack King.

Tim Harrington of Butte, Montana, and Sidney Chapman of Trimountain, signed articles on Saturday, for a wrestling bout to take place at the Calumet theater on Saturday, November 20, at the Cornish style. The match is for a side bet of \$250 and a division of the gate receipts.

Both men will start training immediately. Harrington in Calumet, and Chapman at Trimountain. The latter is in fairly good condition at the present time, and will not require as much work to get in first-class condition as will Harrington. The latter will establish his training quarters at Dunn's hall and will work diligently until the hour set for the bout.

Chapman bases his claim to a match with Harrington, upon the showing made in the tournament conducted a few weeks ago at South Range, against Joe Ziehr of Calumet, who is admitted to be a good match for the Butte man. Although he is a little lighter than Harrington, he believes that his skill in the use of the jackets will enable him to win.

Favor Rowett to Win.
Calumet wrestlers are almost unanimous in the opinion that Jack Rowett of Bessemer, who by reason of his victory over Harrington has a good right to claim the championship of the country at this style of wrestling, will have no difficulty in throwing Jack King, a former champion, in the match which is to be conducted at Hibbing soon. They do not believe that King will be able to return to the ring, anywhere near his old time form, and although he is admitted to be a past master in all of the tricks of the game very little Calumet money will be placed upon him.

There is a bright prospect that the postponed Cornish wrestling tournament will take place at the Calumet theater about the middle of next month. It is thought that all of the principals will be ready to enter then and that a better crowd could be secured, than would be possible if the interest dies down. Calumet promoters who have undertaken this event will consider the new date definitely in a short time and arrange other details of the match.

JOE CANNON INTERESTED.

"Uncle Joe" Cannon, speaker of the house of representatives, is making an effort to buy the franchise of the South Bend club of the Central league and then transfer the club to Danville, Ill. "Uncle Joe's" home.

Speaker Cannon believes a good baseball team would do more to advertise Danville than anything proposed in years. THREE CHAMPIONSHIPS MAY BE DECIDED IN ONE ARENA

Coffroth May Repeat Big Fistic Carnival Staged for Sullivan and Corbett at New Orleans—Jeffries May Surprise Friends and Upset Old Fighter's Dope.

New York, Nov. 8.—When Jack Johnson and Jim Jeffries hook up in their proposed fight to a finish, ring followers will have an opportunity of proving to their own satisfaction the truth of the old statement that a fighter who has been out of the game as long as Jeffries is never able to come back.

Johnson was eminently successful so far as he has gone, but he was lucky enough to come into the championship division when that class had less, and poorer, aspirants for the honors than in any other time in the history of the prize ring. Had he been given credit for any ability whatever, when he was matched to meet Tommy Burns for the title in Australia, the story would have gone up that was raised when he was matched to fight Stanley Ketchel.

When Jeffries attacked the title he had to wade through the biggest and best crop of heavyweights the world has ever known. Corbett, Fitz, Sharkey and Gus Ruhlin were in the heyday of their careers. He gave them all an opportunity, but there was none who was even capable of making the big fellow take one step back.

Unlike Johnson, there was no time when it was even hinted at that Jeffries was not game. Sharkey pounded and Corbett tormented him, while Fitz literally cut him to ribbons, but Jeffries grinned through it all.

When the whole question is finally threshed out, all that goes to make the fighter must be handed to Jeffries. Age and the length of time that he has been out of the game are against him, but that these will prove a serious handicap remains yet to be seen.

Thus far James Coffroth the San Francisco promoter has not submitted his bid for the mill and considerable interest and speculation has developed over what that bid will be. The wily promoter, however, has suggested a new program of events which he would like to stage, which puts a new appearance on the situation.

Coffroth said today: "It has been proposed to me that I make a three-day fight carnival of the affair if I land the big fight. It has been suggested, and it isn't a half bad idea, that in the event of my landing the greatest fight in history that I do as the New Orleans promoters did in the Corbett and Sullivan fight, hold a three-day session and decide three great championships, the feather, light and heavyweights. I have as good material to work on as they did. I think of a three-day show with such stars as Abe Attell, Jim Driscoll, Battling Nelson, Packer McFarland or Lew Powell, and then the big noise, Jeff and Jack. But this is all suggestion and nothing may come of it.



Yale's Fast Football Team Which Defeated Brown 23 to 0 Saturday

New Haven, Conn., Nov. 8.—In Capt. Ted Coy, Yale has one of the strongest men on the gridiron this season. Until this week the coaches have been holding him back on account of an old injury. It is believed he will be in fine fettle for the Princeton game. Coy's drop-kicking has been one of the great features of the season.

A coincidence of the team this year is the fact that the backfield is represented by two baseball captains. "Steve" Philbin will lead the Blue nine next season, while his running-mate, Fred Murphy, captained the championship team of last year. The former is one of the fastest backs ever developed at Yale. His ability is remarkable. Murphy, who plays left back, is a consistent and heady player.

Ford Johnson, who won his "Y" last year, is said to be the first choice among the coaches for the quarterback position. Although light, he runs his team in a snappy manner and is good at finding holes in his opponents' line. John Kilpatrick is the best developed man that entered Yale. At left end he has been playing a fast game. He is a hard tackler and fast on his feet. Last year he was prevented from making his "Y" by injuries. The guardian of the right wing, "Dummys" Logan, is fast at getting down under punts and a sure tackler.

Both "Hed" Hobbs and "Ted" Lilly are sure of the tackle positions. They are veterans and strong on both the offense and defense. The former has no equal on the team for breaking through the line and going down under a kick. Invariably he gets there ahead of even the ends.

ART O'DEA CAN'T QUIT GREAT AMERICAN GAME

Artie O'Dea, who as manager of the Duluth baseball club brought that city one of its baseball pennants, but who has been leading the simple life close to nature of late, cannot stay from the national pastime longer and has decided to shy his cap into the managerial arena again.

It is known that Superior is without a manager for 1910, and it is suspected that negotiations will be taken up with Artie looking toward his assuming charge of that team. Phil Stremmel made himself popular with the Superior management and the fans last season by his work, and he has been considered the most probable successor to Lew Dril. The Superior management has entered into correspondence on the matter, but no definite reply has been received from the powers that be.
