PRESCRIPTIONS WILL ALWAYS BE WRITTEN OUT IN LATIN

Dean of Medical Department of Marquette University Says He Knows of No Reason Why Vernacular Should be Used.

Why do physicians write their prescriptions in Latin, or rather why do they not write them in the vernacular?

This is a question that intermittently for centuries has agitated the public mind, and just now is being discussed in western newspapers.

When it is proposed that prescriptions be written in Latin, it is usually by a doctor who is a student of the law.

Thus a prescription calling for certain drugs in San Francisco might be composed of entirely different ingredients in New York with results that would be obviously disastrous to the patient.

Laymen may not realize the importance of this but it is a fact that it would be positively dangerous for physicians to prescribe in the vernacular.

A physician prescribes for a certain malady and the medicine brings relief. The next time the patient becomes ill and has some of the symptoms of the disease for which he received that prescription his first impulse is to use the same medicine.

No prescriptions probably always will be written in Latin the world over. It would take generations to change and standardize the nomenclature of the thousands of drugs and plants and systems of weights and measures so as to permit of their being written in the vernacular and when that was accomplished it would not result in any practical advantage to patient or physician.

TELEPHONES FOR DESPATCHING.

Northwestern Company Will Use Them on Part of Its System.

A number of the railway companies operating in the states have used telephones for train despatching with success during the past year or two, but they are being utilized principally in regions where regular telegraph stations are closed during the winter months.

The Chicago and Northwestern Railway company is now preparing to use telephones for despatching. The management has purchased from the Western Electric company apparatus for a complete telephone train despatching circuit extending from Chadron, Neb., to Long Pine, Neb., a distance of 123 miles.

Telephone despatching is of special value in regions such as that between Chadron and Long Pine owing to the fact that during certain seasons of the year many of the stations consist simply of sidings. During a large portion of the year these stations are important shipping points for the ranchers. In many places there are no telegraph stations and at such points telephones will be installed, making it possible for any authorized person to obtain stock cars or other freight accommodations much more rapidly than would be possible if it were necessary to handle the business through the nearest telegraph office.

SHOULD BE DISCOUNTANCED.

Further Regulation of Sale of Oleomargarine Declared Unnecessary.

"The fight being made by the butter trust and its agents to drive the oleomargarine interests out of business should receive the condemnation of the public," declared a prominent citizen yesterday.

"Under the guise of seeking remedial legislation to prevent oleo being sold for butter, in my opinion, the buttermakers are endeavoring to throw such stringent restrictions around the manufacture of oleomargarine that its manufacturing cost will be so great as to be prohibitory, in that there will be no market for the product.

"With butter selling around forty cents most of the time there are a

great many people who cannot afford to buy it and are using oleo as a substitute. The oleo manufactured today is just as pure as butter and there is no reason why the common people should not have an opportunity to buy it at a reasonable price.
