EIGHT LOST THEIR LIVES VOTES WILL BE SECURED

**COLLISION ON GRAND TRUNK
ROAD THIS MORNING ATTEND-
ED WITH FRIGHTFUL FATALI-
TIES—WRECKAGE BURNED.**

(Herald Special.)
Durand, Mich., Aug. 25.—Eight people are dead, and their bodies badly scalded and mangled, three others probably fatally injured, three missing and five seriously injured as the result of a collision on the Grand Trunk railroad at Duffield, near here, early today. The Montreal express from Chicago, carrying nine coaches, stopped for engine repairs, and east bound No. 4, running late, crashed into the rear end of the standing train, splitting the Pullman. The wreckage was burned. Rescuers insist that nineteen people are dead, and that a number of the victims have been burned.

**PALESTINE ATTORNEY SAYS THE
RAILROAD CLAIM BILL WILL
PASS THE HOUSE AND SENATE
WHEN BROUGHT UP.**

Austin, Texas, Aug. 24.—W. C. Campbell, an attorney of Palestine, who made such a vigorous fight in behalf of the International and Great Northern claim bill before the house committee last night and secured favorable reports from the house and senate committees, said tonight that the adherents of the bill believed that they had two-thirds vote for the bill in each branch. He said it would be gotten with little difficulty in the house, and that it would be mustered in the senate where the hard fight is expected to take place. If such proves a fact the International and Great Northern claims will be reached by the prospective law.

The announcement that certain members would not vote on the proposition because of being interested, some having judgments and others local railroad attorneys, did not help the bill one particle, he said, as a silent member is the same as a member opposing, for the bill must secure an affirmative two-thirds vote in each house to put it into immediate effect and those not voting did not help the cause one whit.

WARNINGS SENT OUT

**TO SCORES OF VESSELS IN GULF
TO WATCH OUT FOR FIERCE AUTUMN
STORM RAGING TODAY.
APPREHENSION IS FELT.**

New Orleans, La., Aug. 25.—Scores of vessels in the middle gulf today are being warned by wireless of the first fierce autumn storm due to strike the coast between New Orleans and Galveston tonight. The gale originated in the lower Caribbean and has passed through the Yucatan channel northward. Storm signals along the coast are detaining vessels in ports, and apprehension is felt for two steamers of the United Fruit company known to be in the path of the gale. In September of last year two hundred persons were drowned along the coast of Louisiana.

KILLED HER BETRAYER

**Another New Orleans Girl Took
the Law in Her Hands
Last Night.**

New Orleans, La., Aug. 25.—The police of this city are today facing a man-killing epidemic among disappointed girls. Following closely the acquittal of Mamie McLaughlin for slaying Hugh Smith on the plea of the "unwritten law," Katherine French late last night shot and killed Frank Mischler, her alleged betrayer. The girl was arrested and locked up, but feels sure of her acquittal.

\$50,000 Blaze.

Beaumont, Texas, Aug. 24.—The entire plant of the Caney Creek Lumber company at Bonnier was destroyed by fire this afternoon and the lumber yard is still burning tonight. The plant consisted of a modern sawmill, dry kiln and planing mill, and all minor equipment, buildings, etc. One tram locomotive was also destroyed. No estimate of the loss could be furnished at the company's office tonight, but the loss will easily reach \$50,000. There was no insurance. The plant had not been operated for about four months.

Colorado Smoke-Blanketed.

Denver, Colo., Aug. 24.—Shutting out the brilliant sunshine, a blanket of smoke three thousand feet thick drifted over Colorado today, coming from the forest fires eight hundred miles away. The entire northwest portion of the state is covered by the pall which is drifting southeast at the rate of forty miles an hour.

STORM OF PROTEST

**IS RAISED BY THE MINERS IN THE
PITTSBURG DISTRICT OVER
PROPOSITION TO TAX THEM
ONE DOLLAR A WEEK.**

Pittsburg, Pa., Aug. 25.—A storm of protest has developed in the Pittsburg district among the miners over the action of the miners' special convention in Indianapolis increasing the strike assessments to one dollar a week. The district operators declare they agreed to check off only fifty cents of the miners' wages, and to cut them further required a signed agreement. The local delegates to the convention declare they voted down the Illinois compromise proposition on the assurance from the Illinois leaders that the operators would sign the original proposition within a week, giving the miners a victory.

EAGLES PARADED TODAY

**Twenty-Five Thousand Men in Line
at St. Louis—Committee Report
Expected This Afternoon.**

St. Louis, Mo., Aug. 25.—Twenty-five thousand men in vari-colored uniforms and accompanied by scores of Aerie bands formed a brilliant parade this morning. James C. Shanessy, president of the St. Louis Aerie, was grand marshal of the parade, and led the organization through the principal streets of the city. The graft investigation committee is expected to make its report this afternoon. Louisville, Ky., is favored as the place for holding the next national Eagle convention.
