HER LAST LECTURE

Miss Holton Speaks Before the U. C. T. A.

SCIENCE IN TEACHING.

Her Subject—The Ideal Recitation Explained—Maxims to be Remembered by the Teachers—The Lady's Work Has Been Eminently Satisfactory.

THE DISPATCH on Saturday promised its readers a synopsis of the lecture delivered by Miss Holton before the U. C. T. A., but as our limited facilities are crowded to their utmost this week preparing for the publication of the list of delinquent taxes, we cannot fulfill that promise. Miss Holton spoke upon the subject of science, objecting to the teaching of it being separated from the teaching of other studies. Science work should supply the reading lessons even for the younger pupils. A story telling how certain trees form leaves, twigs, etc., was instanced. Description of a hectograph was given and how to make it, its uses, etc., explained.

Miss Holton then placed on the blackboard, the following diagram of an ideal recitation:

- 1.—It must be complete in itself.
- 2.—It must be a link in a chain, one just as strong as the others.
- 3.—It must be joined to what has gone before.
- 4.—The characteristics of the ideal recitation. (a) Definite point. (b) Logical. (c) Clear. (d) Thorough. (e) Interesting. (f) Something taught.
- 5.—Parts of ideal recitation. (a) Introduction. (b) Middle part. (c) Ending.
- 6.—Each part should stand out clearly.
- 7.—Ideal recitation must be connected with the previous life of the children, and their previous knowledge.
- 8.—Ideal recitation must lead to the world of books.
- 9.—Ideal recitation must have important parts and those clearly emphasized.
- 10.—Results of ideal recitation. (a) Increased desire to learn. (b) Increased intellectual power. (c) An increase of organized knowledge.
- 11.—Plan for a particular drill lesson. (a) Rapid drill, kind used. (b) Review point to be taught. (c) Apply all problems to the point. (d) General drill.

GENERAL DRILL LESSON.

- 1.—Rapid mental drill.
 - 2.—Problems of all kinds given, quickly written and oral analysis.
 - 3.—Pass slips or some device.
 - 4.—Explanation and corrections.
- The lady briefly but clearly illustrated every step of this work, but to which no synopsis could do justice. On the board was the following quotation:
- "Much that we say in our lessons will be forgotten, but let us so arrange them that the chief point will stand out forever in the memory like Alpine peaks above a bed of clouds."
- "If we begin at the right end all good things follow."
- This closes the series of lectures for which Miss Holton was engaged. Eminent satisfaction has been given to every teacher and trustee who has had the privilege of listening to her progressive and able instructions.
- Miss Holton has made many warm personal friends among the teachers, and left an impression for good, professionally. A vote of thanks was tendered the lady, and an adjournment taken.

OLD CLOTHES IN DEMAND.

Secondhand Dealers Find It Difficult to Stock Up This Year.

The demand for old clothes appears to be looking up so far as New York is concerned. I do not know whether it is because of the recent election and the consequent outburst of betting on the wrong ticket or the melancholy sequel of the last year's hard times, but reason of which men feel the necessity of wearing out their clothing instead of turning it over to the secondhand dealer.

If you should be accosted on Broadway a couple of times a trip by agents of the secondhand dealers with the question whether you have any old clothes to sell, it may not be taken as an indication that your attire is out of date and coveted by the trade, but that the trade is running short of stock and is rushing out to the fresh supply. It is better to consider the attention a subtle flattery, that you have the appearance of an individual who doesn't care for dress and are likely to have a score of better trousers hanging up in closets for the moths to feed upon.

Twice on a single afternoon last week, while conversing with a friend on Broadway, I was accosted by sharp looking young men in the interests of the secondhand trade. My friend was inclined to resent the intrusion. He said it was getting too hot for him when he was beset by old clothes men every time he stopped on Broadway.

"Is there anything out of the way about me?" he inquired, looking himself over critically. "That is the second time over you've asked me that question today."

"I beg your pardon, sir," said the solicitor for the secondhand clothing house. "We didn't want the suit you have on."

"It is surprising," says a commercial traveler, "how general the use of potatoes as pushovers is becoming in hotels. I have seen them in use in great quantities of the east, whose owners would hesitate for a moment to spend \$10 for a desk ornament to hold pens used by the guests in registering. The mixture of starch, glucose and water in the potato seems well adapted to take up the impurities of ink and to keep the pen point clear and bright, while the alkaloid of the potato, known as solanine, doubtless has something to do with it in the same line. These elements readily take up the tannate of iron, which is the body substance of ink. Chemically speaking, starch is the first base of a potato, and sugar or glucose is its second base. Thus is the humble potato finding another way in which to serve the uses of mankind."—New York Tribune.

COMPETING WITH CHICAGO.

Norway Making Arrangements to Supply London With Mutton.

London will shortly have the advantage of another meat supply—this time from Norway—which, according to the London Telegraph, is perfecting arrangements for supplying the English metropolis with as much mutton, alive or dead, as it can spare for exportation. Systematic experiments were made recently under the supervision of the Stovanger Agricultural society, and the results were so satisfactory that in the approaching cold season it is to be repeated on a larger scale.

It appears that 80 sheep, each weighing about 100 pounds, were fattened for a week or so until they turned the scale at from 115 pounds to 123 pounds. They were then shipped to London, where they realized an average price, after deducting commission, of about \$7.50, and as the total outfit had only been about \$8.50 per head there was a net profit of nearly \$1 on each animal.

Forty were also sent over with the skins, hocks and interior limbs, but of these there was an average loss of 10 shillings per head, partly explained by the skins being damaged through bad packing.

Nevertheless the Stovanger society has come to the conclusion that the business promises to be remunerative, and the English people have thus an additional guarantee of an adequate supply of mutton.
