ALL QUIET AT PINE RIDGE

Indians Held by the State Are to Have Fair Trial and Full Justice

(Special Telegram to Evening Teller.) WASHINGTON, Nov. 6.—Advices received from Pine Ridge agency this morning bring the news that everything is quiet. The prospect of a clash between the government and the Wyoming authorities over the Indians held in custody has passed by. The state authorities will hold the prisoners pending an investigation of the riot. Attorney General Knox has instructed the United States district attorney of Wyoming to see that the Indians have a fair trial and full justice.

CHARGED WITH MURDER

Two Croations Arrested at Southampton and Held For Trial

(Special Telegram to Evening Teller.) LONDON, Nov. 7.—The two Croations who were arrested at Southampton yesterday charged with murdering Contractor Ferguson in Pennsylvania were held this morning and remanded to await the arrival of the Pittsburgh detectives.

Governor to Run Steamboats

Governor Van Sant of Minnesota is reported to be making plans to enter the river transportation business between St. Paul and St. Louis to secure a portion of world's fair passenger traffic. Governor Van Sant was formerly a river captain and still owns several fine steamers. It is said to be the purpose of the governor to place a number of small and fast passenger boats in commission to compete with the Diamond Joe and other big pocket lines.

CASE GONE TO THE JURY

Farris, the Bribe Taker, Will Soon Know What His Fate Is

(Special Telegram to Evening Teller.) JEFFERSON CITY, Nov. 6.—The state rested its case in Farris bribery trial this morning. Judge Graves' instructions of the jury were pointed. The minimum punishment if Farris is found guilty is two years and the maximum is seven years in the state penitentiary. The deposition of Kelly, agent for the Baking Powder trust was not admitted as evidence.

UNITED STATES WILL RECOGNIZE NEW GOVERNMENT

Definite Action Taken at the Cabinet Meeting and Statement will Be Issued to American Consuls and Officers

(Special Telegram to Evening Teller.) WASHINGTON, Nov. 6.—President Roosevelt this afternoon authorized the following announcement and following telegram was sent by state department today to Consul Ehrman at Panama. The people of Panama have apparently by unanimous movement dissolved their political connection with Colombia and have resumed their independence. When you satisfied that the de facto government republican in form and without substantial opposition from its own people is established in the state of Panama, you will enter into relations with it as the responsible government of the territory and will look to it for all due actions to protect the persons and property of the United States citizens and to keep open the Isthmian transit in accordance with the obligations of existing treaties, governing the relation of the United States to that territory.

DECISION IN PROBATE ON BENNETT WILL CASE

Court Finds that Bryan Used No Undue Influence and He May Get the Legacy of \$50,000

(Special Telegram to Evening Teller.) NEW HAVEN, Nov. 6.—Judge Cleveland in the probate court this morning rendered a decision in the matter of admitting to probate the will of the late Pluto Bennett in which \$50,000 is given W. J. Bryan and family. The decision is summarized as follows: "As to the question whether the will was properly executed. I find that there was not any claim that the testator lacked testamentary capacity. I find that he had. I further find that there was no undue influence exercised by Mr. Bryan." The claim was made that

the so-called sealed letter should not be incorporated into the will to become a part thereof and after reviewing the conditions attendant to the writing of such a letter the court finds that the sealed letter is not incorporated in the will. The court expressed no opinions as to whether the letter may be incorporated later. Mr. Bryan is to arrive this afternoon from Nebraska when the court will give a further hearing to the case and his decision in full. This morning's decision was a summary preliminary to extending the memorandum on the records.

COGHLAN WILL TAKE COMMAND

Rear Admiral of "Hoch der Kaiser" Fame Assigned to American Fleet

(Special Telegram to Evening Teller.) WASHINGTON, Nov. 6.—The bureau of navigation announces that Admiral Coghlan and his squadron are expected to arrive at Panama this evening. The president today assigned Rear Admiral Coghlan, familiarly known as "Hoch der Kaiser" to command the naval force. Coghlan was summoned by the secretary of the navy to Washington where he was instructed today. He leaves tonight for Colon on the present fast yacht Mayflower and upon his arrival will immediately assume command of the American fleet now rendezvousing at Colon and Panama.

MAKING A RECORD RUN

BOILER BURST KILLING TWO

Engineer Killed, His Assistant Fatally Injured and Others Hurt

(Special Telegram to Evening Teller.) COLUMBUS, O., Nov. 6.—A portable boiler engine at the state university farm exploded this morning killing Engineer Pepper, blowing his body 100 feet away. His assistant Killgardner was fatally scalded. Professor Vernon Davis who was standing at some distance in another part of the grounds was struck by a flying piece of machinery and seriously hurt. A student named William Bennett was also injured.

ANOTHER BOODLER SENTENCED

PRICES DROP ON STEEL STOCKS

Stock Market Shows Effect of the Lowered Price on Steel Billets

NEW YORK, Nov. 6.—It is announced that the price of steel billets are being lowered four dollars caused by the new low records in steel stocks on the market today. SAM PARKS SENTENCED FOR A TERM AT SING SING

Infamous Walking Delegate Gets Two and a Half Years for His Work in the Tiffany Case

(Special Telegram to Evening Teller.) NEW YORK, Nov. 6.—Sam Parks was sentenced today to two years and a half in the penitentiary for his work on the Tiffany case. His counsel battled for the prisoner and asked for a new trial on a legal question but Judge Newburger refused. The counsel then asked for lenience for Parks, Judge Newburger replied that he had given the matter considerable thought but had concluded that the sentence was the lightest possible under the circumstances. Parks received the sentence calmly and was led back to his cell.

He will probably be taken to Sing Sing this afternoon. Considerable doubt exists as to whether he will survive the sentence. Parks is also under sentence for extorting \$200 from Joseph Plenty. He had begun this sentence when his release was obtained a few months ago on a certificate of reasonable doubt. This was swept away, however, by the confession of Forley Fellow, another walking delegate that both he and Parks had perjured themselves at the trial. A large number of spectators were present this morning including among the number walking delegate McCarty.

COLD WAVE IN CHICAGO

Entire Lake District Experienced the First Touch of Winter Last Night

THIRD AND FINAL DAY OF THE BIG TOURNAMENT

Pennell and Reed Hold High Averages Today and Are Crowding Forbes for First High Prize

The weather today was excellent for the shooters and high scores were registered. More town people visited the grounds to see the last day of sport than at any previous time.

Comments from visitors vote Officers George Tannahil, Jordan, Butler, Cole, Lomax, Frazier, Pennell, Sam Tannahil and members of the local club capital entertainers. "The traps and sky line on the grounds are perfect" can be heard at all times among the strangers.

The big events of the day were the fifth and the eighth. The fifth was for fifty birds, twenty-five birds and rest, and H. Cole of the local club took the first prize with forty-seven targets. The eighth event was a handicap among members of the local club for the Hunter Arms company gold medal. Pennell took the trophy with twenty-four targets. Jent and S. Tannahil shot second with twenty-two.

In the first event of ten targets Turner, Stephens and Bethel scored straight for first; Pennell, Jent, Smith, Forbes and Reed scored nine for second; Hollohan, De France, Knettle, Butler, West, Keeps and Simmons scored eight for third; S. Tannahil, Ware, Brown, Hunter, Robertson and Godman scored seven for fourth; and Lomax, Spence and Howe scored six for fifth.

In the second event of twenty targets Pennell scored a straight for first; Hollohan, Forbes, Stephens, Reed and Godman scored nineteen for second; Turner and Smith scored eighteen for third; Jent, Knettle, Brown, Cole, Winters, West and Robertson scored seventeen for fourth; and Hunter scored sixteen for fifth.

In the third event of fifteen birds S. Tannahil and Forbes shot straight for first; Pennell, Ware and Winters scored fourteen for second; Turner, Hunter, Reed and Godman scored thirteen for third; Hollohan, Smith and Bethel scored twelve for fourth; and Howe, Green, West and Simmons scored eleven for fifth.

In the fourth event for twenty targets Brown scored a straight for first; Pennell Jent and H. Cole scored nineteen for second; S. Tannahil and Smith scored eighteen for third; Hollohan, Ware, Stephens, Winters, Keeps, Reed and Godman scored seventeen for fourth; and Green and Robertson scored sixteen for fifth.

In the fifth event for fifty birds H. Cole scored forty-seven for first; Knettle and Reed scored forty-six for second; Ware and Keeps scored forty-five for third; Hollohan, Smith and S. Tannahil scored forty-four for fourth and Howe shot forty-three for fifth. Eight others shot forty. This event was shot: ten known traps, known angles; fifteen reverse pull; ten known traps unknown angles; fifteen reverse, pull unknown angles, using both barrels.
