Senator Heyburn in an interview in Washington said: "Idaho went Republican in November by 29,303 because there were enough straight Republicans in the state to make that majority. There was no Mormon issue. Some people thought there was. We knew there wasn't, simply kept on talking straight politics."

"Are you for tariff revision?" was asked.

"Well, I would want first of see the schedules that are to be revised," he replied. "We are very well satisfied with things as they are. There is no demand in Idaho for a change."

"The tiger of the jungle" is the way Senators greet Senator Dubois now. This title was conferred upon him during the recent campaign by Hon. W. H. Borah of Boise, who, in reply to a challenge of Charles Mostyn Owen of Salt Lake, to proceed against a score of Mormons accused of polygamous practices, declined by saying: "I am not after the snipe of the valley; I am after the tiger of the jungle, Fred T. Dubois." This title will probably follow Senator Dubois as long as he lives.—Salt Lake Tribune.

Senator Platt of New York has introduced a bill, prepared under the direction of the committee on national affairs of the Republican club of the city of New York, having as its purpose the reduction of the representation in congress of southern states that have disfranchised the negro vote. The measure, if enacted in its present form, would lessen the membership in congress by nineteen, according to the estimate that has been made by the Republican club, which originated it.

President Roosevelt's message appears in this issue. It is worthy of a careful reading, and frankly sets forth the ideas of the administration and suggests much needed legislation. There is no attempt to produce literary effort apparent, and the recommendations are passive and to the point.

Out of 139 decoy prescriptions sent out by the State Board of Pharmacy to Chicago druggists to be filled, twenty-three contained no trace of the drug called for, sixty-six were 80 per cent impure, 10 were 20 per cent impure and only thirty-one were pure. As a result the board will prosecute over 100 druggists for selling impure drugs.

The department of the interior has restored to settlement approximately 45 townships of land in Idaho county hitherto included in the Sawtooth forest reserve. The territory released includes the entire Thunder Mountain mining district which was temporarily withdrawn for forest reserve purposes.

Ex-senator George L. Shoup is lying dangerously ill at his home in Boise City. He has been declining for some time and it is felt that a general breakdown has occurred. Members of his family are greatly worried over his condition.

The senate has reached a decision to vote on the Philippine civil government bill providing for the construction of railroads in the island, on the 16th inst., and in addition transacted considerable other business.

President Roosevelt has given congress a hint to get down to work by stating that an extra session might be necessary.

The Smoot inquiry will begin on the 12th.

The Japs are making satisfactory progress in the Port Arthur siege.

Nelson whipped young Corbett at San Francisco, last Wednesday night.

Spain proposes to impose an increased duty on corn and wheat imported.

A combine has been formed to control the salmon output of the Pacific coast.

Salt Lake and Ogden are infested with hold-ups, two of whom have been captured.

Gen. John M. Wilson has been designated as chairman of the inaugural committee.

There will be only three townships along the railroad on the Minidoka tract of government land.

Jurisdiction of the Colorado Supreme court, in the election cases, will be tested in the federal court.

The grading on the Short Line branch from Minidoka will be completed to the river by the last of the month.

President Roosevelt will appoint Senator Cockrell, of Missouri, a member of either the Panama canal or Interstate commerce commission, as the latter may prefer.

Mrs. Anna Flannigan, a widow of Sterling, Ill. captured a burglar in her house, beat him almost to insensibility, and then marched him to jail with a revolver.

A party of three young people, two boys and a girl, were lost on Pike's Peak last week and suffered extremely from the cold, and reached Manitou in an exhausted condition.

The Southern Pacific has decided to drive a six mile tunnel through the Sierras. This will do away with 1500 feet of mountain grade and abolish nearly thirty miles of costly snowsheds.

Admiral Dewey does not wish to serve as a member of the Russo-British dispute.

R. D. Lawson, a Utah man, committed suicide at Winnip last Monday.

Mrs. Josiah Smith of American Fork, Utah, pierced her finger with a hot pin ten days ago, and died from blood poisoning on the 29th.
