

TELEGRAPHIC NOTES.

WASHINGTON, D. C. May 21.—Coxey, Brown and Jones were each sentenced to twenty days imprisonment in jail for displaying a banner on the occasion of May 15th demonstration on the Capitol grounds.

GREAT FALLS, MONT., May 21.—Two advance agents of the North-western division of the industrial army, are here soliciting funds to provide food for their followers.

WILLIAMSPORT, Pa., May 21.—Cut off from the rest of the world, no railroad communication and no telegraph or telephone communications save the quivering wire over which this message is speeding.

CHICAGO, May 21.—The assassin of Mayor Harrison, Freudergast, trial will be continued until tomorrow. It is stated that the prosecution will ask for continuances from time to time until June 4th, on that date another judge will succeed Judge Chetlain in the criminal branch of the county judiciary.

NEW YORK, May 21.—A driver in the employ of the Street Cleaning Department, who was taken to the Harlem Hospital with a bullet in his back, died without revealing the name of his slayer. It was afterwards found out by the detectives that the story told by Carberry, the murdered man, was a falsehood.

CALCUTTA, May 21.—The Currency Association sent a memorial to the Government, protesting against forcing Council bills upon the market in excessive amounts during the slack export season.

PARIS, May 21.—The author of the explosion in the Hotel Terminus, Emile Henri, was guillotined at 4:04 this morning. Just as day was breaking Henri was led from the Prison de la Roquette to the instrument of death.

PHILADELPHIA, May 20.—A half a million is the estimated loss of property by fire in the heart of the business section of the city. The flames were discovered about half past twelve o'clock in the cellar of the store of the Julius Sichel Company.

BARSTOW, CAL., May 20.—A workman named Cox fell down the shaft of the Side-winder mine and was knocked senseless upon the projecting timbers. A man working below carried him to a place of safety and ran for help.

BARCELONA, May 20.—The death sentences passed upon six anarchists, for complicity in the attempt of Pallas to assassinate Marshal Martinez Campos, were read to the condemned men in the Mont Juch citadel preparatory to the execution by guillotine tomorrow.

DAS MOINES, IA., May 20.—The Kelly Commonwealthers met this evening to discuss a scheme that is on foot to perpetuate the Commonwealth movement, and many laboring men signed an agreement to join the contemplated association. The order is to be of a political nature and will invite the laboring and poorer classes together and force Congress and the State Legislatures to accede to its demands.

WASHINGTON, May 19.—Representative Bland of Missouri, returned to Washington this morning, from the Democratic state convention. He says the main issue will be the question of the free coinage of silver, in the coming congressional campaign in the South and West.

SPRING VALLEY, ILL., May 19.—The company's mines in this city, are on fire at the bottom and the company asked the strikers to allow the men to go to work extinguishing the flames. By a close vote, of a meeting called for that purpose, it was decided not to allow the men to go down.

STOCKTON, CAL., May 19.—Murphy's stage was held up thirteen miles above Milton by two masked highwaymen, one of the men was killed instantly by messenger Hendricks. The second robber returned the fire and seriously wounded a young lady passenger.

ger from Stockton and T. T. Hume. The stage horses became unmanageable and ran away, but were finally stopped. The stage carried the mark of twenty-two buckshot.

BOISE, IDAHO, May 19.—A freight train was boarded at Nampa, by sixty Coxeyites this afternoon, but the train was held. A dispatch from Deputy Charles Sweeney also says that 275 Coxeyites captured a train near the Idaho line, and are speeding east through Montana.

DENVER, May 18.—Another army, composed principally of women, is being organized here. Over 1000 women say they will march to Washington to advocate Coxey's bill.

CINCINNATI, May 18.—One of the latest assertions made by General Fry is that his army is now composed of 15,000 men and that he will have 200,000 men in Washington in sixty days.

FRISCO, CAL., May 18.—The loss of sheep from the recent severe snow storms in the Sierra Nevada foothills is great and thousands have perished. About 40,000 have entered this county and it is estimated that fully one-third of that number have died.

CHICAGO, May 18.—To-day's storm which swept Lake Michigan, was the most destructive that has occurred in many years. The wrecks extend from Glenocoe to the north, where the "Lincolndale" went to pieces, to South Chicago, an air line distance of forty miles.

KENNEL, O., May 17.—Five persons were killed and two fatally injured at 6:30 p. m., by a passing cyclone one-fourth of a mile west of here.

BOSTON, May 17.—Twenty-eight children are reported as lost in the recent big fire. The police say they will all be found.

BOISE CITY, IDAHO, May 17.—Over six hundred members of Coxey's army have arrived near Wallace, and these will join the union miners, it is said, in expelling the non-union men from the Coeur d'Alene. The Legislature refused to pass a bill for the payment of the war of two years ago and they are left without a State militia.

KROSNQA, IA., May 17.—The fleet of Kelly's Industrial army reached here to-day but left immediately for Farmington. From there Kelly will go to Washington to take charge of the Commonwealth army of the United States.

NEW YORK, May 17.—The steamship "Philadelphia" of the Red Line, arrived from Caracas and reports that half of the inhabitants of six cities, which cover an area of about forty square miles, were killed by earthquakes. In three of the cities the shocks lasted two minutes and without any warning the inhabitants were instantly killed.

A foot ball team has been organized at Carson. Two colored boys awaiting trial at Reno for burglary committed in Churchill, broke jail by digging through the wall. They are still at large.

The shipments of live stock from Reno to California during the month of April were as follows: Cattle 121 car, sheep seventeen cars, horses two cars, hogs one car.

It is said there is a proposition on foot to remove the county seat of Douglas county from Genoa to Gardnerville, which is rapidly becoming the business center of the country.

Quite a cheer went up at the meeting of the Ormsby Republican League as half a dozen young men who cast their first vote this year, stepped forward and signed the club roll.—Carson Tribune.

The late heavy frosts had the effect to kill the fruit prospects of this section very extensively. It is reported there will be about half a crop in Reno, Carson and throughout Washoe Valley.—Enterprise.

A committee of Lovelock citizens applied to C. P. Huntington and A. N. Towse while passing through that town the other day for the relief of the Commonwealthers. The town was overrun with them, and it being a small place, the committee asked of the railroad officials that they allow the trains to move them eastward free of expense.

A team of football players came up from the reservation to play a local team, and a fine exhibition of skill was shown. The men were stripped of all clothing except short trunks, and were fine athletic fellows, clean limbed, and with muscles that would do credit to a first-class heavy weight. They wrestled with skill, and used excellent judgment in the disposition of their men. The game was won by the reserve team.—Mason Valley Times.

That the Australian ballot system and the accompanying safeguards thrown by it around the purity of the ballot box are not always adapted to the requirements of the situation has recently been strikingly illustrated in Kansas. The Legislature of that State has given the women the proud privilege of voting at the municipal elections, but unfortunately a section of the ballot law already in vogue before and not annulled by the woman suffrage act, threatens to reduce the new vote to a minimum. The section reads as follows: "The lower limbs of the voter shall be visible as high as the knees from the outside while the voter is in the booth preparing a ticket, the lower part of the booth having to be left open for that purpose."

A tiny electric light fastened to the end of a pencil is a recent invention to enable reporters to make notes in darkness, and to find the keyhole when they reach home.
