

**In Again, Out Again,  
Back Again, is Jagla  
Fate and Judge Sits**

In custody, out of custody, in again and on trial were the rapid events that marked the life of Martin Jagla in circuit court Thursday morning. Incidentally, Pres. Floyd O. Jellison and George Kuriz, representing Jagla, told each other some pertinent things relative to court procedure.

Jagla's case was set for trial before Special Judge Lenn J. Ore Thursday morning. The special judge took the bench and Jellison dismissed an indictment against Jagla, and for the brief span of about five minutes Jagla had no charges of any character against him.

Then the prosecutor filed a new affidavit. The matter coming under the jurisdiction of the presiding judge, Judge Punk assumed the bench again and issued a warrant for Jagla's arrest and ordered that bond be fixed at \$3,000.

Kuriz accused Jellison of trying to keep Jagla in jail for an indeterminate period, told each other "You are afraid to go to trial; you know you haven't any case," Kuriz hurled at Jellison.

"Are you ready for trial?" Jellison demanded.

"Certainly," was the quick response.

The attorneys agreed to try the case upon the fresh affidavit with Mr. Ore again on the bench. He was recalled from his office, and examination of prospective jurors for the case was begun.
