CULVER CADETS MUSTERED IN

BECOME IND. STATE SAILORS UNDER SENATOR GRUBE'S LAW SATURDAY.

Special Law of Congress Gives Authority—Ship Will Be Provided For Them.

Culver, Ind., August 9.—The first battalion, Indiana Naval Reserves, numbering 200 men, was formally mustered in here by Lieutenant William Kennedy adjutant First Regiment, I. N. G., who, in the absence of Adjutant General Perry, had been detailed for this duty by Governor Marshall. Rear Admiral Ross, U. S. N., commandant of the Great Lakes Naval Training station at Lake Bluff, Ill., was present at the mustering.

The members of this addition to Indiana's military forces are enlisted from the cadets of the Culver Summer Naval school in accordance with the provisions of a law passed last winter by the general assembly.

Academy a Naval School.

The naval instruction given on Lake Maxinkuckee covers all the elementary work done by naval reserves and by the government naval training stations. In addition the formation of this battalion outdoes Indiana to receive from the navy department a vessel for more extended drills and work in navigation on the Great Lakes.

INDIAN STATUE HAS ARRIVED

CHIEF MEMONINEE IS ON FLAT CAR AT TWIN LAKE.

Weights 40,000 Pounds—Will Be Set on Site This Week—Will Be Dedicated September 4.

The statue of Chief Memoninee which is to be dedicated at Twin Lake, on September 4th, passed through Plymouth Tuesday, enroute to Twin Lake station and at present located on a flat car, on the Twin Lake siding. The monument with its base etc., was sculptured at Barre, Vermont, and was done under contract of B. C. Southworth and Son, of this city. The complete monument weighs 40,000 pounds, and consists of base, di. cap, and statue. The die to the pedestal weight 25,000 and will be quite a task to set. The contractors of this city will employ a 30,000 pound hoisting crane, and will begin on the job Wednesday expecting to have the monument set by the end of the week.

DOG TEARS SMALL BABY

TWO-YEAR-OLD CHILD MAY NOT RECOVER FROM THE WOUNDS.

Grandchild of Emil Gohr Residing Near Hibbard, Victim of Frightful Attack.

A large collie dog belonging to Emil Gohr, who resides 3-4 miles north of Hibbard, without warning of any sort, or without betraying any symptoms of madness, set upon the two-year-old grandchild of Gohr, which has been making its home there, Sunday, and inflicted frightful lacerations upon the forehead face, head and neck of the child which may result in the death of the child. The baby was playing in the sand outside the door of the home Sunday morning. The dog had entered the house from the back door, and when discovered in the house was driven out the door by Mr. Gohr. The dog bounded out the door, and set upon the baby, which was only a few feet away. The horrified grandfather saw the dog bury its teeth in the face of the child, shake the baby and then seize the child again. Gohr was soon upon the animal, and after a severe cutting, drove the creature off. The dog was then shot. A physician summoned to care for the baby says that it may recover with close attention, but that the odds are strong against it.
