The best commercial paper, or that which is backed by good collateral, is at ten per cent. for regular loans, and for outside parties at one per cent. a month. Bankers look upon the business situation as exceptionally good; they have not known the wholesale trade of the city working so easily as now for a number of years.

They have quietly built and own a strictly first-class line of iron steamships—the only line plying between this country and Europe carrying the United States flag. These vessels have all the modern improvements for passengers and freight, making good time from Liverpool to Philadelphia and from Philadelphia to Liverpool, forming a weekly line, and through the diligence of their officers and agents at Philadelphia, Chicago, and elsewhere, they are being filled with freight and passengers in both directions. This, the American line, has a large and growing business with Chicago. Some of the heaviest importers of goods in this market are importing exclusively by this line. Philadelphia is also a controlling interest in the new iron steamships, built for them on the Tyne. This is the line of the International Navigation Company of Philadelphia, and is called the Red Star Line, and like the American line, is running full cargo fortnightly, and is being built up by the Pennsylvania railroad and its feeders. The export and import trade is increasing as rapidly at Philadelphia, if not more rapidly, than at any other of the Eastern seaboard cities. Philadelphia has three elevators for grain, the first of the West. Philadelphia is the junction of the Pennsylvania railroad. This elevator has a system of 600 bins, and can keep 600 car-loads of grain as if in no many cars, and can be easily and speedily handled. The advantage to be derived from this is, that the West and the East have the very identical grain be shipped sold upon its merits. Then they have a second elevator built of iron and brick, situated at the Washington dock. This has a capacity of a quarter of a million bushels of grain, and is used for storage and transfer.
