Mrs. McKinley, widow of the late President William McKinley, died at Canton, O., Sunday.



President Roosevelt will attend the funeral Wednesday afternoon. Mrs. McKinley's remains will rest beside those of her husband in the mausoleum just erected.

Mrs. McKinley was 59 years old and was the mother of two children, both of whom died young. She was mistress of the White House from March 4th, 1897 to September, 1901.

PREST MURDERER

George's Drains to Her Obituary. Thousands of Georgia's citizens gathered Saturday in Atlanta at the unveiling ceremony of the granite monument to the memory of Gen. John B. Gordon.

In the parade a long line of soldiers and active veterans marched through the streets. The oration of Gen. C. A. Evans, was heard with interest, and as the two daughters of Gordon pulled the cord and revealed the statue the strains of "Dixie" rang out, and the words of the song by the multitude mingled with the old-time songs of the veterans who fought under General Gordon's order and led.

A feature of the day was the presence of Mrs. Gordon, widow of the Confederate commander, and his two daughters, Mrs. Bart, widow of Gen. and Mrs. Bishop Brown, of Vermont.

The statue, cast in copper bronze, stands on a broad pedestal of Georgia granite. The figure of Gordon is represented seated on his favorite mare, his head bowed. The name "Gordon" is inscribed on the pedestal, and the bronze bas-relief, one representing Gordon at the battle of Spotsylvania, when before the division he insisted on General Lee going to the rear, the other bearing figures typical of the three phases of Gordon's life, typifying the soldier, the statesman and the patriot.

The statue, cast in copper bronze, stands on a broad pedestal of Georgia granite. The figure of Gordon is represented seated on his favorite mare, his head bowed.
