

LIZABETH'S BACKERS TIRED

Presiding Judge Oyster Made a Failure at Starting Horses.

LEFT THE CHOICE AT THE POST

Owing to Late Arrival of Starter Cassidy Judge Oyster Tried His Hand in the First Race, but He Made a Bitter Mess of It—Results and Entries at the Other Tracks.

Big fields, lively speculation and four of the best winners lively backed were the features of the afternoon's sport at Alexandria Island yesterday. Owing to the late arrival of Starter Cassidy at the track the presiding judge attempted to send the horses away in the first race. He left Elizabeth, the 4 to 5 favorite, and St. Mark, and then was glad to be relieved of his thankless job.

Markstone, who won the opening event, was 90 to 1 at one time, and closed at 30 to 1. The other winners were all either first or second choices. The attendance was fully 2,000.
