

## DETENTION CAMP NOW READY SURE

Small Crowd Who Showed Up at Depot But Could Not Get Away Yesterday.

ONLY 20 PEOPLE IN FIRST LIST WANTED TO GET OUT OF TOWN AND ADDITIONAL LIST IS PUBLISHED THIS MORNING.

Judging from the way the people flocked to Dr. Porter's office two weeks ago when first there was talk of a detention camp, it was expected that some of the residents here were more than anxious to get out, and yesterday, when eighty names of persons who were eligible to admission in the camp was published in The Journal, a rush was expected.

Contrary to expectations only twenty out of the eighty applied to Dr. Anderson for cards of admission to the camp, and out of the twenty, three of them were detained on account of their temperature being above normal. Those who were detained were: L. Medlock, temperature, 98.2-5, pulse 96; Mrs. P. Q. Hall, temperature, 99.3-5, pulse, 100; H. G. Caldwell, temperature 99.1-5, pulse, 125.

After the task of taking temperatures was completed and those who passed the examination were making preparations to leave the city Dr. Porter received a telegram from Surgeon Banks stating that the camp would not be ready for occupancy until today. The telegram reached the doctor at 11:40, too late to notify those to whom cards to the camp were issued, so there was nothing to do but to have them stopped at the train.

## SKULL CRUSHED BY BELL-CLAPPER

YOUNG BOY THE VICTIM OF A HORRIBLE AND UNUSUAL ACCIDENT.

Jacksonville, Oct. 3.—With a fracture on his skull six inches long, the little eight-year-old son of Ira Thomas, agent of the Atlantic Coast Line Railway, at Green Cove Springs, was brought to Jacksonville last night and placed in St. Luke's Hospital.

The little fellow attended the opening of the Green Cove Springs school yesterday and it was at the school building that the injury was received. In some manner, as the little fellows were playing around the building the bell clapper fell from its fastenings and struck the little Thomas boy on the head, inflicting a wound which may cause his death.

Dr. Clark accompanied Mr. Thomas to Jacksonville with his little boy last night. An ambulance was in waiting at the union station and the boy was hurried to the hospital.

Physicians immediately proceeded to perform an operation and removed the lacerated bone for about two inches around the wound. Reports from the hospital as to the little fellow's condition are very unfavorable, though everything known to medical skill is being done to save the life of the little boy.

## STORM NOT FELT IN LOWER GULF

FISHERMEN RETURNING FROM HONDURAS WATERS SAYS NO STORM OCCURRED THERE.

The Mobile Herald of Monday says: Another freak of the elements is recorded by Captain R. Johannessen of the steamer Hiran, which arrived here this morning from Ceiba, Spanish Honduras, having passed over the bar last night, and remaining in quarantine long enough to complete the period of five days required by quarantine regulations governing steamers from tropical ports.

For the past few days many rumors of a terrific storm on the Mexican gulf have reached Mobile and other southern gulf ports, but from what can be learned it seems that the storm confined its operations along the coast, and not extending to any great area in the gulf. Asked upon arrival if he had encountered the storm Captain Johannessen said: "What storm? I've encountered no bad weather. It has been calm all the way on the trip. In fact, it has been too calm most of the time. Once I encountered a slight swell from the northwest and then again from the northeast, but nothing else."

From this it was inferred that the storm was along the gulf coast and did not extend into the path of steamships in the tropical trade.

After the first party of refugees are discharged from the camp, the camp will be ready again to accommodate eighty people.

## NEGRO KILLED AT McDAVID

DEPUTY BREWTON ARRESTED MAN CHARGED WITH CRIME AND SHERIFF VAN PELT WENT AFTER HIM.

There was a difficulty among negroes at McDavid last Saturday night in which a negro by the name of William Smith was killed. L. B. Bingham, another negro, is charged with the crime and is now in the county jail.

The arrest of Bingham was made by Deputy Sheriff Brewton, but he was sick at the time and could not take his prisoner to the city, so Sheriff Van Pelt went after Bingham and placed him in jail.

Another negro was also placed in jail being in some way implicated. He is also held as an important witness, as he is said to have been an eye witness to the affair. Smith was badly cut in different places, leaving no doubt that the man who wielded the knife which was used meant to kill him.

## NEW RULE FOR UNIFORM FUND

DEDUCTIONS MADE SEMI-MONTHLY FROM POLICE OFFICERS SALARIES.

There was considerable dissatisfaction yesterday among the police officers when they received their checks, covering the last half of September to find that they had been "cut" to the extent of \$2.50 for uniforms.

Heretofore it has been the custom of the board of safety to have the men purchase uniforms twice every year, and after the uniforms had been purchased three consecutive monthly deductions were made to pay for the same. It was found, however, that this was decidedly a losing practice for the city, as some of the men quit the service or were discharged therefrom while still indebted to the city.

The board a few weeks ago adopted a new plan, which went into effect yesterday. The new arrangement provides that the sum of \$1.75 be deducted from each semi-monthly check the year round and that this amount be placed to the credit of the men. When uniforms will be purchased for them it will be taken from this fund. If, however, an employee should resign or be discharged, after several deductions are made and he has bought no uniform, or paid for the last one purchased, then the amount to his credit is paid over to him in cash.

In this way the men pay to cash. In a number of cases, when uniforms in some instances were purchased by parties who would immediately resign from the service, the city saved the same, thereby causing the city to pay the cost.
