DAMAGE SUIT.

M. E. Fritz vs. John S. Williams.

Under the head of circuit court proceedings the Yazoo Herald last week contained the following reference to the damage suit of M. E. Fritz, ex-postmaster of Lexington, against Hon. John S. Williams, of which a full account was given in THE STAR last year when the suit was entered:

"After calling the motion docket Court adjourned until 2 o'clock Wednesday evening. The first case was that of M. E. Fritz vs. John S. Williams. This is a damage suit for \$25,000. Mr. Fritz claiming that his character has been damaged to that amount. The lawyers in the case are, for plaintiff, E. E. Baldwin, Esq., of Jackson; for defense, Hon. A. J. McLaurin and Hon. W. P. Tackett. The testimony of the plaintiff having been ruled out by the Court, Fritz's attorney allowed judgment to be entered for the defense. The case will be appealed to the Supreme Court. Mr. Fritz will hardly get a cent out of this suit.
