Lets Go in the Ohio Powder Co.'s Mill, Near Youngstown.

Bodies of Dan Davis and George Lynch Blown to Atoms,

And No Parts of Them Have Been Found - Explosion Was Heard for Miles Around - Cause of Accident a Mystery - Two Men's Narrow Escape.

YOUNGSTOWN, O., Sept. 11.—A terrible explosion occurred at the mills of the Ohio Powder Co. Friday morning shortly after 8 o'clock.

The explosion occurred in the pressroom. It was heard for many miles in the country about Youngstown.

What caused the disaster is hardly known. The fireman claims that he left the pressroom about five minutes before the explosion.

The foreman, who had been in the room, left just a moment before, and escaped. Only the two men killed were in the place at the time of the explosion.

THE BANCROFT

Ordered to the Golden Horn for a Three Years' Cruise.

WASHINGTON, Sept. 11.—Formal sailing orders to the Bancroft have been issued by the navy department, directing Commander Charles Belknap, her commanding officer, to leave New York Saturday, and after taking explosives at Tompkinsville, to proceed to Gibraltar and there report by telegraph to Adm. Selfridge, commanding the European station, for further orders.

The department has been officially informed that the vessel will be ready for a three years' cruise in foreign waters in time to obey these orders.

This is the second formal step in carrying out the president's determination to have an American national vessel on guard in the Golden Horn to support the American minister, and in emergencies to serve as a refuge for American citizens at Constantinople.

It is stated that Commander Belknap has no specific orders as to whether he shall stop en route for coal at the Azores, but at any rate the Bancroft should reach Gibraltar in less than three weeks.

A CYCLONE

Sweeps Over the Central Part of Paris, France.

Several Persons Reported Killed and Injured by Flying Debris.

Windows of the Palais de Justice Blown In—Roof of the Opera Comique Blown Off—Large Trees Torn Up by the Roots—Heavy Hains.

LONDON, Sept. 11.—A dispatch to a news agency says that a cyclone from the southwest passed over Paris at half past two o'clock Thursday afternoon, doing much damage in the center of the city.

The dispatch adds that isolated deaths were caused by the storm and that many persons were injured.

Traffic in the streets was stopped for two hours by a severe wind and rain storm that passed over Paris Thursday afternoon.

The wind blew with hurricane force and the downpour of rain was torrential. Much damage was done and several persons were injured by being struck by flying debris.

Two hours before the storm broke the atmosphere gave indications of its coming. It was dark and sultry and the clouds had a peculiarly lowering appearance.

A reporter of the Temps who witnessed the cyclone from the top of an omnibus says that it did not last for more than a minute.

What appeared to be a tall pillar of smoke advancing, and imagined that there was a large fire. But almost immediately he saw the branches of trees snapped off and countless chimney pots hurled to the ground.

Those on the omnibus were untouched. The west end of the city wholly escaped the fury of the storm, but eastward along the river way much destruction was caused.

Between the Pont St. Michael and Pont Neuf 40 large trees were torn out of the ground and blown into the Seine.

Some of those in the path of the storm were dashed against houses and injured. Many cars were literally blown to pieces, so violent was the force of the wind.
