

FULTON'S QUOTA MORE THAN FILLED

Military Board Ready To Certify More Than Enough Men To Fill The County Quota—First Thirty Per Cent to Chillicothe Next Week

With some cases deferred for further consideration and some absentees yet to be heard from, the Fulton County Military Board are nearing the end of their work with the two hundred men of the second call. Forty-six out of the one hundred and forty-six that passed the physical examination made no claim for exemption; thirty of those who filed claims for exemption were denied exemption by the local board, making a total of seventy-six. One hundred nineteen had previously been certified to the district board as subject to call for service. The seventy-six mentioned in the foregoing makes a total of one hundred ninety-five which is fifty three more than the quota for the county. The lists of men claiming no exemption and those whose exemption claims were not allowed by the local board are printed herewith.

The first thirty per cent of Fulton's one hundred and forty-two men will begin to go forward to Chillicothe next week, probably about Wednesday, the first five per cent making a squad of about eight men will start for the cantonment under the leadership of Otto Finkhouser who will act as sergeant for the trip. Robert Bissonezzi will act in the same capacity for the second five per cent who will leave about Thursday of next week; five per cent will leave each day thereafter until the entire thirty per cent are in Chillicothe. The next thirty per cent will be called about September 15th. The local board has arranged to have the unmarried men and those who can best be spared from the farm work go first.

FATAL ACCIDENT

Frank F. Gineman of Southwest York Killed in Auto Accident Last Sunday Evening—Little Daughter Suffered Broken Arm.

An auto accident that deprives a wife and her five small children of husband and father occurred last Sunday evening when Frank F. Gineman, a farmer residing on the county line road in the Southwest corner of York township met almost immediate death. Mr. Gineman who is a nephew of Mr. Fred Lockman of this city was returning with Mrs. Gineman and their five small children in their Napoleon car, to their home from Liberty Centre, when a mile or more out of Liberty the car turned turtle in an eight foot ditch. Mr. Gineman's death must have been almost instantaneous as life was extinct when he was extricated from the wreckage. The only other occupant of the car to be injured was one of the little girls who suffered a broken arm. The car which was rather heavy wrecked was brought to the Wauseon Garage. Lloyd Edgar of the Edgar VanRensselaer Undertaking Company was called and took charge of the funeral services which were held Wednesday morning in St. Caspar's Catholic church and interment made in St. Caspar's cemetery. Mr. Gineman was a comparatively young man being only a little past forty years of age and a prosperous farmer. The sincere sympathy of the entire community goes out to Mrs. Gineman and her children in this sudden bereavement.

628 MILE RUN

John A. Karlson, Wills Overland Salesman Will Run From Minneapolis to Toledo—Will Stop in Wauseon on Monday Night September 3rd—To Attend The Wills-Overland Sales Congress in Toledo Next Week

John A. Karlson, a salesman for the Minneapolis and St. Paul branch of the Wills-Overland Inc., who is a winner in a sales contest recently closed, started on a 628 mile Marathon from Minneapolis to Toledo last Friday, August 24th. Mr. Karlson is an athlete as well as a prize salesman holding the world's amateur 25 mile skating record as well as a hundred world's record against time. The Wills-Overland Inc. are giving their winning salesman a cruise on the Great Lakes, starting from Toledo September fourth and Mr. Karlson says that he is "running to catch the boat." He will also attend the "Sales Congress" which the Overland will hold in Toledo next week. He is accompanied by one of the Wills-Overland cars carrying a driver and a rubber, the minimum day's run is 32 miles and the maximum 74 miles. Mr. Karlson is due in Wauseon on Monday September 3rd and will remain here Tuesday night, pressing on to Toledo Tuesday morning. This city will certainly be honored by the presence of this man, 44 years of age who is demonstrating the possibilities of physical training and fitness. In past years our young men have gained incentive and inspiration from the veteran Weston when he stopped in Wauseon on his various trans-continental hikes. Mr. Karlson the much younger man will undoubtedly have some valuable suggestions to give concerning the care and development of the body as well as advice for those who are ambitious in regard to running records; we shall be very glad to publish anything along this line that we may gather from him in next week's issue of the Tribune.

So far as the time at which Mr. Karlson will arrive in Wauseon next Monday is concerned, we are unable to give definite information, but we think that Mr. Robert Gottschalk the genial "Overland Man" at the Depot street Garage will be in position to tell some thing about it on Monday.

The itinerary is as follows: August 24th, Minneapolis to Red Wing 51 miles; August 25th, Red Wing to Winona, 62 miles; August 26th, Winona to Elroy, 68 miles; August 27th, Elroy to Madison, 74 miles; August 28th, Madison to Harvard, 67 miles; August 29th, Harvard to Chicago, 62 miles; August 30th, Chicago to 31st, Chicago to LaPorte, 50 miles; September 1st, LaPorte to Elkhart, 42 miles; September 2nd, Elkhart to Kendallville, 51 miles; September 3rd, Kendallville to Wauseon, 80 miles; September 4th, Wauseon to Toledo, 32 miles.

DEFENDERS OF DEMOCRACY

Patriotism in Fulton County Rain Proof—Splendid Address by Hon. Frank Mulholland—Banquet—Band—Red Cross Housewives and Dance

That it takes something more than a rainy day to dampen the real loyalty and patriotism of the citizens of Fulton county was amply demonstrated last Tuesday. Although the rain made necessary the postponement of the Ball Game scheduled for 2:30 in the afternoon and prevented the parade of citizens and the selected men of the county's quota which had been planned for the program was carried out as planned and all in all it was a great day for the county. Stores were closed at one o'clock in Wauseon; the Archbold land arrived in town and made everybody who heard them glad they were here every minute they stayed. People from various parts of the county gathered into the county seat and had it not been for the rain would have crowded with the citizens of the county. The Archbold band marched to the court house and gave a short but excellent concert preceding the address of the day by Hon. Frank Mulholland of Toledo. Mr. Mulholland always eloquent, surprised himself in the address ringing with real patriotism, which he delivered to the selected men of Fulton county's quota of the National Army and the citizens assembled to arouse their appreciation of the men who will answer the call to uphold the principles of Democracy and fight if need be to secure the permanent peace of the world. Mr. Mulholland in a finely arranged oration set forth the past history of this nation and the fundamental principles of human rights and political equality for which it has and does stand. He recited the atrocities and willful deeds of "frightfulness" of which the Prussian Military Autocracy have been guilty; the long and patient forbearance exercised by this government under the indignities and insults and criminal acts heaped upon the fact that the declaration of war was the result of a refusal to surrender for this nation and others, the right to sail the high seas as demanded by the Prussian Autocracy and that this nation was forced into this war to protect the very principles for which it stands and upon which it is founded. "This is not the time for criticism but for action" said Mr. Mulholland. The government that gives you your liberty and protects your rights has a right to expect your loyal support and your help in protecting and continuing its existence. The army of the United States is fighting as much for the rights and liberties of the German people as for the rights and liberties of our own people. It is a war for a true democracy and against military autocracy; its ultimate purpose is to attain a permanent peace for all the people of all the nations of the world a peace which will make possible the enjoyment by all people of the inalienable rights of all men as set forth in the Declaration of Independence. These are a few of the many ideas set forth by Mr. Mulholland in an address which many who heard it say was the best patriotic address they have ever heard.

Judge Wolf spoke in behalf of the citizens of the county assuring the selected men of the county's quota as well as the enlisted men of the appreciation of their fellow citizens of the sacrifices which they are making and that those who are left behind will support them in every way possible; stand ready to do any thing they can for them while they

are away and provide them with any thing they may stand in need of so far as possible.

At six o'clock a banquet was served to the selected and enlisted men of the county in the Knights of Pythias Castle Hall; the use of their hall for this purpose had been tendered to the committee in charge by a resolution passed by the K. of P. Lodge at their last regular meeting. The banquet was furnished by voluntary contributions of the citizens of Wauseon; everyone being given an opportunity to contribute. It was prepared and served by the ladies of the town, the members of the Pythian Sisters Temple directing and helping and furnishing china and silver. The banquet itself was fine and did credit to the ladies and people of Wauseon. Comrades of Lesure Post G. A. R. were invited guests and were well represented; the editors of the county and other prominent citizens were also among those who gathered about the banquet tables. The Archbold band furnished delightful music. Comrade Allen Shadle acted as chairman and toastmaster and gave a short address from an "Old Soldier" to the "New Soldiers" which rung with patriotism. Mayor Hoy gave a short but splendid address of welcome which made every one present feel that he was speaking what he felt.

Following the banquet Judge Wolf as chairman of the County Red Cross, in behalf of all the Red Cross workers of the county presented to each selected and enlisted man present a "Housewife" containing scissors, other things which a soldier will find convenient and necessary in camp or service. Young ladies who had been serving the banquet distributed the "Housewives" to about fifty men. Short addresses from editors Waltz and Kenyon and an interesting talk from the view point of an enlisted man by Howard McClarren followed.

The program of the day was closed by a dance tendered to the selected and enlisted men of the county at the city hall assembly room; over one hundred were present and all enjoyed a good time.

It was a day long to be remembered and demonstrated that the citizens of this county are possessed of a loyal and deep seated patriotism; proud of the men who go to represent them in this war and determined to support them and co-operate with them in every way possible.


