JUDICIAL CONVENTION.

The Republicans of the first subdivision of the tenth judicial district of Ohio, composed of the counties of Hancock, Hardin, Seneca, and Wood, are requested to meet in delegate convention at Findlay, Ohio, on Wednesday, June 28, at 10 a. m., to place in nomination one person as a candidate for common pleas judge for said district.

MRS. C. L. HUNT DEAD.

One of Perrysburg's Most Estimable Ladies Passes to the Beyond.

On Tuesday, June 13, at 6 o'clock in the evening, occurred the death of Mrs. C. L. Hunt from heart disease. The deceased had been in poor health for the last few years, but only for the past couple of months did her family realize that death was inevitable. She fully realized that she was soon to pass from this earth and talked about it to those who attended her, and with that courage and strength of christian fortitude, which was so marked a trait in her character during her life, expressed herself as being ready to meet her Savior.

Mrs. Hunt, formerly Miss Carrie L. Hagaman, was born at Brighton, Monroe county, N. Y. April 30, 1836. She was married November 15, 1859 to Lewis M. Hunt at which time the young married couple settled in Perrysburg, and has resided here since, Mr. Hunt having died some years ago. At the age of 16 Mrs. Hunt united with the Presbyterian church at her birth place and when coming here was transferred to the First Presbyterian church in which she has been a devoted member ever since.

The deceased leaves a daughter, Harriet, wife of Joseph Brandhuber, who has the sympathy of a large circle of friends in her bereavement. The funeral services were conducted by the Rev. G. A. Adams at her late home on Front street at 2:30 o'clock, Thursday afternoon. The remains were laid to rest in Fort Meigs cemetery by the side of her husband.

Death of A. M. Russell.

A. M. Russell, for several years a resident of Perrysburg, died at his home in Bowling Green Tuesday morning at 6:30 o'clock. The cause of his death was paralysis. He experienced his first paralytic stroke in February of 1897 while at work in the Auditor's office at the court house. Since then he has at intervals had six strokes, each one a little more severe, and has been practically helpless since the first. The last stroke occurred Sunday, affecting his throat and tongue so that he was unable to take any nourishment, and he lingered until Tuesday morning.

Deceased was 69 years old and leaves a wife, one son, Charles W., and one daughter, Mrs. Frank Reed. The funeral was held on Thursday at 2 p. m., under the auspices of the Masonic fraternity. Rev. Dillon of Bowling Green conducted the services. The remains were buried in Oak Grove cemetery.

Mr. Russell for many years held trusted positions in the various departments at the court house. He held the office of deputy treasurer and served out an unexpired term as treasurer. So well did he perform his duties that he was elected to this office for the succeeding term, serving until 1871. After four years of retired life he again entered the political field, and was elected county treasurer a second time. At the expiration of that term he served as deputy auditor under three administrations. In society circles Mr. Russell was a member of the G. A. R. and the Masonic fraternity.
