BARN BURNED

A large barn on the farm of Gus Wenig, two and a half miles east of Tontogany on the Kellogg road, was burned to the ground Sunday morning at 2:30 by fire of an unknown origin.

With the barn were consumed a clover huller, a feed grinder, a corn cutter, a binder, a corn drill, and a cultivator, all as good as new also a quantity of hay. The loss will aggregate probably about \$2,200 or more.

LYCEUM THEATRE

Salvation Nell to Begin Sunday, August 27.

"Salvation Nell" a divine comedy of the New York slums, under the direction of Vaughan Glaser, will be the Lyceum Theatre offering for four days, starting with next Sunday's matinee including 25c matinee Tuesday. As a picture of contemporary slum life, a revelation of how half of the teeming millions of New York struggle and survive, "Salvation Nell" is probably the most powerful object lesson among the numerous efforts in that direction that has been on the stage in recent years, and Mr. Glaser is to be congratulated on offering Toledo theatregoers their first view of this stirring drama at popular prices.

As a story it is simplicity itself. The subject is treated with amazing directness, a degree of daring almost unexampled in an American play, and happily with no inclination to mawkishness or theatrical platitudes.

Two wonderful stage pictures are presented, the most realistic representing the interior of a barroom imaginable, the first act and a graphic section of Cherry Street (New York) which constitutes the scene of the last act. Stage naturalism can hardly go farther. The first act with its motley gathering of half criminal habits, and pathetic touches of life, ending in an assault and an arrest; the last act with its vista of squalid tenements, the Italian green-grocer in the basement, the fire escapes and windows littered with laundry and bedding, the corner saloon, and the animated picture of the street group, and meeting of the Salvation Army. The whole production is characterized by a picturesque atmosphere of colorful realism seldom equaled.

Petitions of candidates for the election of Wood County's representative to the state constitutional convention need not be filed, according to the election laws, until Oct. 7, one month before the general election. THE FIRST COURT

For Wood County Opened on the 3rd of May, 1820.

The question of when and where the first Common Pleas court for Wood county was held, was recently referred to the writer who was Clerk of Courts at the time. The question was settled by reference to the official records and the first Journal entry in Journal No. 1, of the Court of Common Pleas of Wood County, O., reads as follows:

At a Court of Common Pleas begun and held in the Town of Maumee in and for the County of Wood, in the State of Ohio, and on the Third day of May in the Year of our Lord One Thousand Eight Hundred and Twenty (the time and place designated by law) Present, the Honorable George Tod, President, and Horatio Conant Samuel Vance and Peter Oliver, Esquires, his associates. The Court being opened, the commissions of the associate judges were read publicly, all bearing date of the 1st day of March, 1820, each to be operative for the period of seven years from and after the 1st day of April 1820, on each of which commissions was duly indorsed the Oath of Office etc.

Thomas R. McKnight was appointed Clerk to the Court for the period of seven years from and after the 3rd day of May, 1820, he having produced a certificate of his qualifications, properly attested by three of the Judges of the Supreme Court of said State of Ohio. Bonds as required by law were duly executed by the said McKnight with acceptable Securities, conditioned for a faithful performance, etc., of all and singular the duties of Clerk to the Court aforesaid; the oath of office prescribed by law was duly administered in open Court to the said McKnight, as clerk aforesaid.

C. I. McCurdy was appointed by the Court to prosecute the pleas in behalf of the State for said County for the present time. The Sheriff having re-

Sunday-schools, Young Men's Christian Associations, and civic organizations are encouraging their young people to come. The State Fair grounds will present a beautiful picture this year. The beautifying effect of flowers and shrubbery will be seen.

SCHOOLS INTERESTED.

Since Agriculture is to be taught in public schools the teachers are taking great interest, and discussing this subject and the State Fair at their institutes. Nearly one thousand dollars is the sum being spent in the Horticultural Hall on a model landscape, which alone would pay every home-maker to visit the Fair to see. Every teacher ought to see this new feature.

Monday, August 8th, is Ladies' Day. Thousands of women will be admitted free of charge. The Granges in many places have discussed the value of the State Fair to the ladies. The exhibit will consist of mounted specimens of insects and diseases commonly affecting orchards, small fruits, nurseries, shade trees and farm crops; material showing injury caused by these pests. Samples of spraying material, models of spray pumps, limbs showing proper methods of pruning; charts and enlarged photographs showing different development of insects, pruning, spraying and other orchard practices; microscopic mounts of common pests; an illuminated case with lantern slides showing many things of interest to orchardists and farmer. Infected nursery stock showing diseases and insects to guard against. Model bee hive, bee tools, comb infected by foul brood, diseases, different races of bees; literature of the Division.
