THE ENGINEERS GETTING READY FOR THE FLAMMABLE EXPLOSION IN OCTOBER.

NEW YORK, Aug. 7.—An interesting account of the contemplated improvements in the Hell Gate canal is given by Lieutenant Kirby, who says that 80,000 cubic yards, or 168,000 tons, of rock have been taken out of the channel. All this rock, it is a solid mass, would be equal in size to a building 200 feet square and 110 feet high. The rock is being laid with great care, and there is a danger of rock falling from the dynamite unless it is judiciously handled.

THE BRITISH IN HERAT.

THREE BLOODY CRIMES.

WHICH WERE EXPLOITED TO-DAY ON THE GALLOWS.

Three Murderers Hanged at Fayetteville, N. C.—A Quarrel Over Some Land Causes a Murder—A Negro Kills His White Mistress and Another His Brother.

FAYETTEVILLE, N. C., Aug. 7.—Following are the histories of the crimes for which J. Howard, Thomas Gee and Thomas McNeil were hanged today.

One night last summer the wife of E. C. Blackman, a farmer living on the east side of Cape Fear river, found her husband in the barn dead. His throat was cut. Howard, a shifty fellow, had sold Blackman a piece of land, on which the latter still owned a small balance.

On the day of the homicide Blackman went to Howard's house and paid the note, and the two men went away together.

They were in each other's company the greater part of the day at Blackman's house. The two made frequent visits to the barn and drank freely of Blackman's wine. Later in the evening persons passing heard the men quarrelling. At bedtime Blackman's wife, becoming uneasy at the prolonged absence of her husband, went to the barn and found him. Howard was arrested next morning. He was convicted of murder at the November term of the Superior court and was sentenced to be hanged on the 12th of this month. An appeal was taken to the Supreme Court, which on the 12th of this month affirmed the verdict of the lower tribunal and at the May term Howard was executed.

Thomas Gee, an aged negro with stunted body and distorted limbs, lived in a shanty here with a poor old white woman. She was found yesterday morning with her head bent to pieces, apparently by an axe. The evidence pointed to Gee as the murderer. He was convicted at the same time as Howard.
