QUEEN VICTORIA'S SEMI-CENTENARY. A million strangers united with several millions of Londoners, on Tuesday, June 21st, in observing the entrance of the queen and empress, Victoria, upon the first year of her reign. The royal procession was gorgeous and ten thousand voices rang out "God save the queen" in Westminster abbey. The spectacle as a whole and in detail exceeded anything ever known in history. The day was fine. Ten thousand troops, representing all branches of the service, guarded the line of the procession and kept order. The queen herself was dressed in black, and riding in an open carriage on a special June day, viewed the decorations and the people with great apparent interest.

The queen's passage along Piccadilly was one of the most interesting episodes of the day. On passing through the Wellington arch, into this famous street, the queen looked up at Apsley house, the residence of the duke of Wellington, and as she passed the mansions of her intimate friends she glanced somewhat hastily at the houses especially on the west side of the street. It was by no means until Devonshire house was reached that the queen began to realize the grand preparations that had been made to greet her. Here the marquis of Hartington had had a spacious gallery erected, from which many hundreds of gaily-dressed ladies waved their handkerchiefs and cheered the queen.

At a late hour, Tuesday evening, at Cincinnati, United States Marshal Under arrested Vice President E. L. Harper, and cashiers B. E. Hopkins and Anson Baldwin, of the Fidelity bank, for "willfully misappropriating funds, bonds and credits of a banking association, by unlawfully issuing without the authority of the directors or depositors to the amount of \$700,000." Harper and his two men were represented by Judge Jordan and the Attorneys Jones. They waived examination and were admitted to bail. Harper in \$75,000 and the other two in \$15,000 each. W. B. Morehead, Eugene Zimmerman, Adam Wagner, C. H. Chatfield and William Woods are the bondsmen.
