HONORS FOR THE KAISER.

England Will Spare No Effort to Make Him a Welcoming Guest.

London, June 20.—Enormous preparations are being made in London for the reception of the German Kaiser. The fireworks, it is claimed, will be on the most magnificent scale ever displayed in England's capital.

The Kaiser will arrive in England on the fourth of July, according to programme, and proceed to Windsor, where he will remain until July 8, meantime being present at several functions, such as the wedding of the Princess Louise, daughter of the Prince and Princess Christian and the silver wedding and garden party at Cumberland Lodge.

On July 8 the Kaiser will arrive at Buckingham Palace, and attend an opera at the Covent Garden. On the 9th he will attend a garden party at Marlborough House, and Albert Hall in the evening. He will lunch on the 10th and on the 11th he will lunch at the German Embassy, and go to the Crystal Palace. After a visit to the Naval Exhibition, he will leave England on July 13.

Close Vote in the Commons.

LONDON, June 20.—In the House of Commons Mr. Sydney Buxton moved that after July 1, 1892, no person under 14 years of age should be allowed to work in factories for longer than half-time. Secretary Matthews objected that if children under 14 were not allowed to work full time in factories they would go into other employment. The motion was rejected by a vote of 189 to 164.

Quarrymen on Strike.

AGUSTA, Me., June 20.—A serious strike is in progress at the quarries of the Hallowell Granite Quarry at Granite Hill. An engineer employed at the mill is a non-union man and refused to join the union. The quarrymen, who are union men demanded that he be discharged, which the company refuse to do. Thus the men, about 85 of them, refused to work.

Lord Chancery Has Begun.

LONDON, June 20.—The Earl of Granville (Lord Chancery) has given it to be understood that he will not take his seat in the House of Lords until his wife has entirely recovered her engagements in connection with the stage. He declined in an interview to state whether he would be liberal or conservative in politics.

Attacks the Triple Alliance.

ROME, June 20.—The Government is seriously disturbed by the publication of a proclamation by the Radical Committee in which the Triple Alliance is represented as ruling the country by compelling it to maintain an enormous army in time of peace.

We May Get Guatemala.
