List of Cases Tried in the Court of Quarter Sessions Last Week.

Com. vs. James Lucas, assault with intent to kill; not guilty.

Com. vs. Daniel Smith, libel; settled.

Com. vs. Angelo Recenetti; aggravated assault and battery; guilty assault and battery; sentence suspended.

Com. vs. Charles Heverly, John Heverly and Thomas Martin; assault and battery; not guilty.

Com. vs. George Graffius, assault and battery; settled.

Com. vs. George Thomas, assault and battery; not guilty, but pay half costs.

Com. vs. William Bukey, assault and battery; not guilty.

Com. vs. S. T. Wingert, assault and battery; sentenced to pay \$10.00 fine and serve thirty days in county jail.

Com. vs. William F. Wingert, larceny; sentenced to pay costs, \$100.00 fine and undergo six months in county jail.

Com. vs. Punxsutawney Street Passenger Railway, manslaughter; continued.

Com. vs. Rosie Rich and Pauline Gallo, assault and battery; continued.

Com. vs. Charles McHugh, desertion; settled.

Com. vs. John Stehle, carrying concealed weapons; sentenced to pay costs and \$100.00 fine.

School Libraries.

Prof. R. B. Teltrick, our worthy county superintendent, is making an effort to have libraries opened in all the schools of the county, and the effort is meeting with considerable success. Recently Prof. Teltrick sent a circular letter to all the teachers in the county containing some wise pointers for the good of the schools, and in that letter he said the following concerning libraries:

"A teacher can do no more valuable work in school than to develop in his pupils a love for good reading. 'Give a man a taste for reading, and the means of gratifying it, and you place him in contact with the best society in every period of history, with the wisest, the wittiest, the tenderest, the bravest, and the purest characters who have adorned humanity.' 'What we read determines the quality of mind and tendency of character.' 'A library is not a luxury, but one of the necessities of life.' During this year I desire that a library be established in every school in the county. Your first effort perhaps should be to convince your pupils and patrons of the necessity of a school library. The plan for securing funds is left entirely at your discretion. Some teachers and pupils have raised money by entertainments, subscriptions, festivals, etc."
