FOREIGNERS IN GLOBE

The increase of foreign labor in Globe is in a great measure to be deplored. Foreigners who come to this country to become citizens, to abide by and support the laws of the country, to educate their children in the manners and customs of the country and to invest their savings here, should be given every encouragement. This class is not a detriment to the locality in which they take up their residence. It is the element of distinctively low-grade foreigners, of which class Globe has more than it has ever had, that this article refers; the foreigners who are making more money in a day working in local mines than they could make in a month in their own country; who are herded in miserable shacks, not, of course, from poverty, but the desire to live as cheaply as possible; who patronize local merchants only when absolutely necessary and who send out of Globe and out of Arizona thousands of dollars each monthly pay day.

On the two days following the last pay day, it is estimated that at least \$20,000 was sent to foreign countries, principally Italy and Slavonian countries. The first day the local postoffice issued foreign money orders to the extent of \$5,400 and the following day \$4,700, a total of \$10,100. This of course does not include almost a like amount sent out in drafts through the banks. Business men state that in the various lines their trade is not as good as when there was only half as many men employed in the mines and when the great majority of them were Americans. While not generally opposed to foreigners, the Silver Belt believes that whenever practicable local mine owners and managers should give the preference to American miners, both for the betterment of their future interests and for the best interests of the camp and community.

The Arizona miner's motto should be: "Copper the market."

Ruef is undoubtedly a genius. It may be true that he made the confession to save the lives of his aged parents, who are without doubt greater sufferers than himself because of his crookedness in the past, but he should not be made an object of hero-worship because he has thrown up the sponge before his losing fight began. The lowest crooks and grafters in the world have often the greatest filial love, so that Ruef is not entitled to any more respect or indul-

commendation because he wishes to spare his father and mother unnecessary sorrow.

Ruef says in his statement published in yesterday's Silver Belt that corporations thought they had to pay for favors and privileges and did so; that had they asked for certain franchises without opening a barrel, the supervisors would have granted them. If the corporations were laboring under any delusion regarding the grafting proclivities of the municipal officials, it was certainly the fault of the latter, although the corporations themselves were equally to blame in the matter. Ruef admits having been the go-between, which he says was a necessary function. He was the man to take the "goods" from the corporations and hand it to the supervisors, but there is undisputed evidence to show that Ruef and Schmitz secured the bulk of the boodle and the puppets who sat on the board of supervisors took what they could get.

Volumes could be written concerning the rottenness of San Francisco and its awakening, but all would lead to one conclusion: That the experiment of the labor union in politics is the most dismal failure in the economic (or political) of modern times.

Certificate of Organization of a Corporation Under the General Law.

The undersigned, officers of a corporation organized at Kittery, in the State of Maine, at a meeting of the signers of the articles of agreement therefor, duly called and held at the office of the Lawyers Incorporation and Transfer Company and in the town of Kittery, on Saturday the 6th day of April, 1907, hereby certify as follows:

The name of said corporation is Arizona-Boston Copper Company.

The purposes of said corporation are carrying on the hereinafter named business, to-wit:

To purchase, lease or otherwise acquire any mines and lands in the United States or elsewhere, or any interest therein, and to explore, work, exercise, develop and turn to account the same; to quarry, mill, smelt, reduce, refine, dress, concentrate, amalgamate and prepare for market ore, metal and mineral substances of all kinds and to carry on any other operations which may seem conducive to any of the company's objects; to buy, sell, manufacture, and deal in minerals, ores and finished products, plants, machinery, implements, conveniences, provisions, and things capable of being used in connection with mining operations, or required by workmen and others employed by the company; to construct, carry out, maintain, improve, manage, work, control and superintend any roads, ways, bridges, tramways, reservoirs, water courses, aqueducts, wharves, furnaces, mills, crushing works and conveniences which may seem directly or indirectly conducive to any of the objects of the company, and to contribute to, subsidize or otherwise aid or take part in any such operations.

To buy, sell and own dredging plants, and articles used in or about dredging operations and the real estate proper for carrying on such business; and to make contracts for and perform the work of dredging and removing and carrying away by land or water, excavated or dredged material; to reclaim and fill in low lands by diking them or depositing upon them rock, soil or other material; to build docks, walls and piers, and to do all things incidental to, and proper to be performed in said business.

To acquire, hold, improve, lease, operate and sell timber, farming, grazing, mineral, oil and other lands, and the products thereof; to build, construct, maintain, and operate plants and works for the development of such lands and for the handling, preparing and rendering commercially available all of the various products thereof.

To purchase or otherwise acquire, operate and maintain hotels, buildings, stores and warehouses.

To acquire streams, lakes and small ponds for irrigation purposes or otherwise. To build, acquire, own, charter, and operate vessels propelled by steam or otherwise, and to construct, complete, furnish, maintain and conduct lawful lines of communication and transportation and to conduct, carry on and transact a general transportation business of passengers and freight in any lawful manner, and upon its property to construct, conduct and operate a transportation business in any manner deemed proper. To acquire and use, sell or otherwise dispose of the whole or any part of the good-will, property and rights, and to undertake the liabilities of any person, firm, association or corporation, engaged in a business similar to that of this corporation, and to pay for the same in money, stock or bonds of the corporation, or otherwise. To enter into, make, perform, and carry out contracts of every kind and for any lawful purpose with any person, firm, association or corporation, or with any government, incidental to the business of this company. To borrow and raise money by the issue of or upon warrants, bonds, debentures and other negotiable and transferable instruments or otherwise. To hold, purchase or otherwise acquire, sell, assign, pledge or otherwise dispose of shares of the capital stock, bonds or other evidences of indebtedness created by any corporation, and while the owner thereof to exercise all the rights and privileges of ownership, including the rights to vote thereon.

To guarantee the payment of dividends or interest on any shares of stock, bonds, debentures or other securities or obligations of this or any other company in which the corporation may be properly interested whenever in the judgment of the Board of Directors proper and necessary for the business of the company; to aid in any manner any corporation whose stock, bonds or other obligations are held, or in any manner guaranteed by the company, and to do any other acts or things necessary for the preservation, improvement or enhancement of the value of any such bonds, stocks or other obligations.

To remunerate any person or corporation for services rendered or to be rendered, in placing or assisting to place or in guaranteeing the placing of any of the stock of the company, or in or

about the formation or promotion of the company or in the conduct of its business.

To use and apply the surplus earnings of the corporation, or its accumulated profits authorized by law to be reserved, to the purchase of, or investment in, its own stock in payment or satisfaction of indebtedness to the corporation, and to release and sell any of the stock so purchased or required, to such extent, in such manner, and on such terms, as the Board of Directors of the corporation shall determine, it being provided, however, that stock shall not be declarable in dividends, unless a majority in interest of the stockholders so determine; but the capital stock of the company shall not be decreased, except as provided by the laws of Maine.

To apply for, purchase or otherwise acquire, and to hold, use, own, operate and rent, sell, assign or otherwise deal in any trade marks, trade names, copyrights, patents, inventions, improvements and processes used in connection with or secured under Letters Patent of the United States or elsewhere or otherwise, and to use, exercise, develop, grant licenses in respect thereto, and otherwise turn to account any such trade-marks, trade names, copyrights, patents, licenses, processes and the like, or any such property or rights; and with a view to the working and development of the same, to carry on any business which is necessary or incidental thereto.

The company may from time to time conduct any of its corporate business in any of the states, territories, colonies or dependencies of the United States and in any and all foreign countries, have one or more officers therein, and therein to hold, purchase, mortgage, and convey real and personal property necessary or incidental to carry out the purposes of this corporation; provided, however, that nothing herein contained shall be construed to authorize the corporation to transact business in any other state, territory or foreign country contrary to the provisions of the laws of such state, territory or foreign country.

In carrying on its business, or for the purpose of attaining or furthering any of its objects, to do any and all other acts and things, and to exercise any and all other powers which a co-partnership or natural person could do or exercise, and which now or hereafter may be authorized under the provisions of the general laws of the State of Maine pertaining to corporations.

Provided, however, that the following corporate purposes shall be exercised only in states and jurisdictions other than Maine, namely, the construction and operation of railroads, or aiding in the construction thereof, telegraph or telephone companies, and gas or electrical companies, and such businesses are to be carried on only in states and jurisdictions when and where permissible under the laws thereof.
