INTERURBAN FOR VALLEY POINTS

ELECTRIC RAILWAY PLANNED FOR PHOENIX, MESA AND TEMPE--FRANCHISE GRANTED.

Andrew Neilson, justice of the peace at Tempe; Redmond Toohy, well known contractor, and Harry J. Bennett, prominent mining man, were awarded a franchise by the board of supervisors of Maricopa county to build an electric railway from Phoenix to Mesa.

New York capitalists are backing the enterprise, and stand ready to expend \$160,000 in the construction and equipment of the railway, which will afford quick transportation between Phoenix, Mesa and Tempe.

According to the franchise to be granted by the supervisors, the road begins at Eleventh street and Tempe road, and runs past the insane asylum on that thoroughfare. From Tempe to Mesa it will go over the Mesa road past the Lily creamery and Hayden place.

The franchise is for a term of fifty years, and construction must begin within three years of the franchise forfeited. The applicants agree to pay 1 per cent of their earnings into the county treasury after the road has been in operation five years. Major Calhoun, the engineer, who is now building an electric road between Chicago and St. Louis, is one of the principal backers of the project. "We will build first between Tempe and Mesa, and between Tempe and Phoenix as soon as we can build a steel bridge across the Salt river. We already have the funds with which to carry on the work, and will start at once on surveys. We mean business. The road is to be about sixteen miles long."
