Southern Railroad War.

CHATTANOOGA, Sept. 9.—The bitterest rate war that has ever occurred between Southern railroads is now in progress, and to-day's developments bid fair to make it even more general and determined. The war was commenced two weeks ago by the Western & Atlantic railroad, which made a cut of 55 per cent in Eastern rates out of Chattanooga. This cut was done on account of rivalry existing between that line and the East Tennessee, Virginia & Georgia road. The cut was not met and thereupon the Western & Atlantic officials announced that the low rates would be permanent. At once the East Tennessee made a cut of 60 per cent. on Eastern business out of Atlanta and the Richmond & Danville was brought into the fight. It is now thought the Western & Atlantic railroad will open a ticket office in Knoxville and begin an indiscriminate cut to all Southern points. The Louisville & Nashville is being drawn into the fight, and all Southern lines are becoming involved.

IN MEMORIAM.

MAYFIELD—Died, at his home at Tallula, Issaquena county, on the 31st of August, 1885, of dropsy. Aged 81. MAYFIELD, in the 14th year of his age.

Mr. Mayfield was an old and highly esteemed friend of the writer, and none esteemed him more or appreciated his high and noble nature better. He was born in Franklin county, Georgia, near Carnesville, April 28, 1812, and came to Vicksburg in 1833, as clerk in house of J. A. Lane, and afterwards was in business there with a Mr. Goodman. He then went to Arkansas and remained about two years, and from there to Lake Providence, where he acted as deputy sheriff, and afterwards clerk of the court, and was highly recommended to President Taylor for the office of United States Marshal. About the year 1854 he moved to Issaquena county, and was deputy sheriff for his brother, F. E. Mayfield, and by his upright conduct, his gentlemanly deportment and assiduity to business, was elected to that office when his brother retired; which office he held until the close of the war. He married two years ago Miss Florence Folkes, a native of Warren county, whose untiring attentions contributed much to his comfort during his long and painful illness. We are well aware that these few lines can mitigate the grief of his family but little, but as his friend, we feel impelled to offer this tribute of respect from a heart overflowing with burned memories at the shrine of a dear friend. The brightest flowers are called first, and in the language of the poet:

"The good are too good on earth to stay,
While the bad are alas! too bad to take away."
