COMMISSIONER BRADEN

ON HIS THIRD JOURNEY OF INSPECTION OF ROADS.

His Report on Tassim - Their Defects and Necessity of Improving Them - Necessity of Roads, Etc.

To the Hon. Judge and County Commissioners

In compliance with my duties as County Commissioner, according to the act of the last Legislature, and being Supervisor of Precinct No. 4, I proceeded on my third journey, and inspected the following roads: I started at the corner of John L. Gembler's pasture, where the W. W. White road and the new Sutherland Springs road connects with the new Gold road. Thence proceeded on the new Sutherland Springs road till I reached the Los Arroyos, Calaveras and Lodi road. In proceeding on said road I found a creek impassable without a culvert, but since a place about 100 yards lower down, on L. F. Gembler's land, is more practicable, and the consent of the owner can be had free of charge, I therefore recommend that the road overseer have full power to change the road to the Gembler land on the line of Warrenberg's pasture. From there I proceeded to the land of Henry Echterhoff, finding the road three-quarters of a mile from the public school, called the Los Arroyos school house, and since, by running the said road closer by, will not lengthen it of any consequence, and thus giving the school community from both sides for said school a more convenient and better road than the present one, particularly more satisfactory to the owner of the land, he being willing to donate what land thereby cut off (two acres or more) to the public school. I then proceeded to the Calaveras and Chupaderos, finding many ravines and wash-outs which would take considerable labor to put in a good traveling condition.

Therefore, I recommend that Mr. Hildebrand, the road overseer, should be furnished with the necessary tools and the amount of \$100 be appropriated for lumber needed for the culvert and beams necessary to put the crossing in fair order. Thence I proceeded to the neighborhood of Wilson county and then crossed into the new Sulphur Springs road, finding several arroyos in bad condition before reaching the Chupaderos creek, which needs more work than the hands of the road are equal to. Therefore, I recommend that, whenever the county convicts can be spared to work it, or that \$100 be appropriated to provide the county convicts cannot be placed there. The road from there to the W. W. White road needs a great deal of work, but there are a great many laborers under the control of Road Overseer Neal Campbell, though the same cannot be done without expense. About a mile of this road is not cut out, which the road overseers should do, and put in traveling condition, so that the public can have the benefit of it without traveling on land not recorded as public, as I consider the road laid out sufficient for public use. On the W. W. White road I found two miles of road which is not cut out; I therefore recommend that \$50 be appropriated for cutting out the above road and the balance of the new Sulphur Springs road, which is not clear of brush, as the hands on the above named roads are insufficient for the purpose. From there I found the road in good condition, with the exception of Albert Ackerman's cow pen, which projects about six feet into the road, and should be removed. The new Gold road from the Rosillo to the city limits, under the supervision of Ferd Theiss, some places are in bad condition, and since he has not sufficient hands to work it, I recommend an appropriation of \$50 be made, to assist him to complete the same, as the city has not given any inlet for any roads, and the county has not the power. Twenty-eight million dollars' worth of gold and silver and securities will be placed in the new postoffice building in a short time. There will be six tons of gold coin. The mere carting of this pile of valuable material from Fifth and Chestnut to Ninth street will require more wagons than are used in cleaning the streets of the city in a week. The work will be entrusted to the Express company, and the men who will ride on the vehicles containing the silver will each one be an arsenal on wheels. In addition to the \$12,000,000 worth of silver there will also be nearly \$4,000,000 in gold coin. The annexed statement shows in detail just what the Subtreasury would remove if the vaults were ready to-day: Standard silver dollars, \$8,866,075; fractional silver coins, \$5,345,400; gold coin, \$2,354,580; minor coin, \$334,200; gold certificates, \$7,674,810; silver certificates, \$620,330; United States and National bank notes, \$4,157,130; total assets, \$42,773,515.
