SALE OF PUBLIC LANDS BY LAND COMMISSIONER

C. V. Savidge Announces Results of Recent Land Sale—Good Prices Received

Commissioner of Public Lands Clark V. Savidge announces the following results of the sale of public lands held in Twenty-three counties of the state on January 6th:

The land under 102 applications was offered for sale and on 25 of these there were no bids.

The amount received for the upland was \$82,322.82, while the timber sold brought \$30,620.75.

Only 61% of the uplands and but 23% of the timber offered was sold.

These figures, following the results of the November sale, when approximately only 45% of the land and timber offered was sold, indicate that the present administration of the land office is fully protecting the interests of the state by appraising both land and timber at its full market value.

Doctor Haled in Court for Practicing Without License

Dr. J. D. Banes was haled into Justice J. J. Bixler's court Tuesday on a charge of practicing dentistry without a license. He was represented by Attorney A. H. Mohler and plead guilty to a technical violation of the law.

Attorney Mohler took occasion to make a few remarks to the court for his client, pointing out the defects and absurdity of the state law in this case and relating the difficulties a new man, regardless of merit and proficiency, had to contend with to secure a certificate to practice. Dr. Banes was assessed the minimum fine of \$50, which was promptly remitted by Justice Bixler.—Cashmere Record.

State News Items

One five hundred thousand acres of state and railroad land, one-third of which is in the state of Washington, have been released by an order of the general land office of the United States.

The government has just sold 12,000 cords of cedar wood for shingles from the Wenatchee national forest. The shingles manufactured from this wood, laid six inches to the weather, would cover 2 1/2 square miles of roof.

City Clerk Hackett of Tacoma reports a net profit of \$17,162.20 from the operation of the police court the past year.

By a small majority the delegates to the convention of the International Union of Shingle Weavers, Sawmill Workers and Woodsmen, in session at Aberdeen last week, passed a resolution discontinuing endorsement of the socialist party. The union has endorsed socialist principles at the two previous conventions.

Advices from Pullman state that many unemployed men from Seattle, Spokane and other cities of the state are seeking enrollment at the college for the six weeks' winter course in agriculture, horticulture, forestry, home economics and other practical subjects.

State Bank Examiner W. E. Hanson will attend a convention of examiners from all states at Chicago this week, at which an attempt will be made to devise some means to allow state banks to come under the national currency act.

The shipments of lumber from the port of Seattle, including the entire district of Washington, to foreign port for 1913 were given out recently as amounting to \$5,905,408, representing shipments totaling 431,411,000 feet. For the fiscal year ending June 30, the lumber exports amounted to \$5,730,682.

Washington is beginning to class as a state of factories. Labor Commissioner E. W. Olson having a total of 1,806 concerns now listed on his books for certificates. In addition, about 50 factories have been inspected but certificates withheld pending the making of changes prescribed. In the books of the labor commissioner are listed 300 shingle mills, 204 machine shops, 201 small saw and planing mills, 184 laundries and 110 power plants and substations. There are 39 breweries and bottling works and the same number of fish canneries, 41 box and paper and 28 garment factories.

If chicory or any other adulterant is used in coffee served in any hotel, restaurant or boarding house, a notice to this effect must be posted in the dining room, according to a ruling just issued by the state department of agriculture. Similar rulings will be put out by the food commissioners of Oregon and Idaho, as the result of a joint conference of the authorities of the three states held recently.

Colonist Rates

Colonist rates to the west will go into effect on the transcontinental railroads March 15, and will be operative until April 15. The rates will be as follows to all points west of Missoula, Mont: From Chicago, \$38; from Philadelphia, \$47; from New York, \$55; from Minneapolis and Kansas City, \$30. To Missoula and points east of there the rates will be \$5 less than the above quotations.

In view of the near completion of the Panama canal and the coming expeditions on this coast, it is believed the travel will be heavy when these rates go into effect. The railroads figure that these features, combined with the drouths of last summer and the storms of this winter will cause many to turn their faces toward the Pacific coast.

FRUIT TREES CANNOT ESCAPE TAXATION

Chelan County Assessor Notified to Assess Orchard Property—Peach Trees Being Cut Out

The state tax commission has notified the Chelan county assessor that it will take the same position in reference to the assessment of fruit trees that the old commission did, expecting assessors to add the value of fruit trees to orchard property which they are valuing. All the horticultural counties with the exception of Chelan have been following this method, in effect disregarding the exemption law, the constitutionality of which has been seriously questioned.

According to the report of District Horticultural Inspector Darlington to the state department of agriculture, approximately 50 per cent of the bearing peach trees of Chelan county have been taken out during the past year. The report shows a greater production of fruit in the district, comprising Chelan, Okanogan, Grant and Douglas counties, than ever before, and considerably better prices received than in 1912.
