THE CITY COUNCIL FORCES RESIGNATION OF ENGINEER SPAHR.

Action on Purity Petition Deferred For One Week. Will Equalize F Street Improvement By Order of the Court. Bills Allowed, Etc. The mandate of the superior court, in the R. S. Jackson case, was read, and the clerk was instructed to give notice that Improvement District No. 60, will be equalized on August 12. A complaint from the N. P. Ry. Co., that the alarm bell in East Aberdeen was being tampered with, was read and was referred to the police committee. Engineer Spahr tendered his resignation, with the statement that it had been demanded by the committee. The resignation was accepted, and J. J. Ryan was appointed in his stead temporarily, and the committee was directed to secure a permanent engineer. Wm. Griggs complained that Supt. Semmen was using his official position to solicit plumbing work. The matter was referred to the water committee for investigation. The committee on team asked another week, as the team they had figured on was not suitable. The American Mill Co. offered to furnish the lumber for the sidewalk petitioned for by R. A. Wiley. Supt. Semmens reported that the new dumping ground was ready, and that the smoke stack at the pumping station was repaired. In accordance with the recommendation of Supt. Semmen, it was decided to lay the wooden water mains on Hume street, between F and Broadway, instead of on Heron street. The clerk was directed to give notice of the new dumping ground. The matter of the purity petition was brought up. As it had been referred to the entire council as a committee of the whole, and as Morgan and Fuller were absent, the matter was continued until the next meeting. A petition, numerously signed, asking the passage of an ordinance granting licenses for the sale of liquor in original packages was denied. A petition asking for the planking of the alley in block 3, W. & B.'s addition, was referred to the street committee, as was a petition for planking Front street, South Aberdeen, to the Cosmopolis line. It was decided to employ Engineer Hunt to establish such monuments as the tide land survey requires. The clerk was instructed to advertise for bids for the city printing. The street committee was instructed to file a report on the regrade of B street at the next meeting. Carter & Gilroy were notified that they would be required to put a hinge on their pile driver, so it could pass under the electric wires. The assessment rolls of Improvement Districts 85 and 88 were equalized. The marshal was directed to file report of deficiencies in the street lights. In addition to the regular salaries, the following bills were allowed:
