THOUSANDS OF MEN TO BE DISCHARGED

Harriman Issues Orders to Railroad Managers to Cut Expenses and Discharge Everybody Possible--All New Work Is to Be Stopped.

(By United Press.) SAN FRANCISCO, Oct. 12.—Orders have been received by the local officials of the Southern Pacific to cut expenses down to the minimum and to stop all new work. President E. H. Harriman has wired the general managers of all his roads that they must, without delay, cut down expenses in every department under their control. His instructions are explicit and are given out in this form:

Harriman Makes Denials. NEW YORK, Oct. 12.—The attention of E. H. Harriman was called to the telegram which he was reported to have sent to the general managers of the Southern Pacific railway company, instructing them to reduce all expenses other than maintenance and to stop improvements on account of the stringency of the money market.

Farrell, Charley Chamberlain and Hervey Lindley, the latter being brought here from Sacramento to do fine work in Seattle for Harriman, and who, if this campaign had not been started, would naturally become president.

HARD HIT

DESTROYED BY FIRE

(By United Press.) SAN JOSE, Cal., Oct. 12.—The "Arcade," one of the largest dry goods stores in the heart of the shopping district on First st., was totally destroyed by fire last night. The loss is estimated at \$400,000, which is partially covered by insurance. The fire broke out shortly after 10 o'clock and raged for two hours before the department was able to get it under control. The entire block between San Fernando and Santa Clara was threatened and only the rapid work of the firemen prevented the spread of the flames to the buildings on the same block.
