# LAW REACHING OUT FOR GILL

Will Have to Answer for Contempt of Court and Also Faces Arrest on Charge Sworn to by Official of the Public Welfare League—Chief of Police and Various Vice Promoters Are Involved in Both Cases.

Mayer Hiram C. Gill and Chief of Police Wapenstein will have to show cause on Friday morning to Judge Gilliam why they should not be punished for contempt of court in permitting the restricted district to run unmolested, contrary to the injunction order issued by him two weeks ago.

# SUPREME COURT IS UNMASKED

overtaken an established principle of law? This is one of the charges against the system in Washington. Some ten years ago one Green, a miner, was injured in an accident in a coal mine in Pierce county operated by the Western American company. The mine caved in for lack of timbering. The law required the company to keep a supply of timbers on hand, to be used by the miner in timbering his work.

Superior Judge W. O. Chapman (who, it may be of interest to not a candidate for the supreme bench before the hand-picked judicial convention at Tacoma August 3, 1910) tried the case, accepted the plea of the company, and threw Green out of court.

Green appealed and the case was reversed by the supreme court in a decision written by W. H. White, an appointee of Governor Rogers, and chairman of the non-partisan judicial convention at Tacoma September 26, 1910. This was a unanimous decision. In it the court affirmed the doctrine that when a person violates a law designed to protect the lives of his employees, he cannot, in a suit for damages, set up his violation as a defense under the doctrine of assumed risk.

This direct assault on the Green rule of the law of the killed and wounded failed, but the judges elevated to the bench proved useful in getting other decisions desired by special interests. Tomorrow's story will tell of the reversal of the law. "Stop, look and listen."

Two methods of escape were open to them. They could get the legislature to change the law or they could get the court to reverse the rule. They tried both. The effort in the legislature was successful, but its effect was not retroactive. The effort in the court failed, but its history illuminates the evils of the system.

The first of these factory act cases to be decided by the court was that of Hall vs. the West & Slade Mill company, appealed from Chehalis county in 1904. It was argued first before a court of five judges. But while it was pending a bill was rushed through the legislature increasing the court to seven members, and the case was re-argued before the larger court.

Now, in most factory act cases there are two defendants, though only one appears of record. One is the mill company, the other is the insurance company insuring the mill company against accidents. Keep this fact in mind when you note who were the new judges appointed by the corporation messenger boy governor nominated by the Farrell-bossed convention.

Root was attorney for the Aetna Indemnity company and the Maryland Casualty company. Crow was attorney for the United States Fidelity & Guaranty company. The fact that both, though the rule laid down in the Green case wrong was known to corporation lawyers, and they were appointed on the recommendation of corporation lawyers.

Then what happened? When the case was reargued before the enlarged court, 18 prominent corporation lawyers joined in a brief asking the reversal of the Green case. This brief was not served upon the opposing counsel, but copies of it were sent privately to each of the seven judges. The case was vigorously argued, and as vigorously discussed by the court. In deciding it the four old judges who had joined in the Green decision upheld the Green rule.

But the three new judges—Rudkin, who was nominated by the Farrell convention, and Root and Crow, who were appointed by the governor—were not so easily won over. They voted with the four old judges to uphold the Green rule.


