HEROIC DEED BY MISSIONARIES IN CHINESE REVOLUTION.

When the two days' battle at Hankow was in progress and the shells set fire to the city, the flames quickly spread to the Wesleyan mission house for blind Chinese boys, located on the river bank. Dr. Booth, in charge of the Wesleyan hospital and mission houses, with several other missionaries and native Christians, embarked on a Red Cross steamer and went to the rescue. A cross-fire of rifles swept the river and scores of bullets struck the steamer, but by skillful work Dr. Booth and his assistants rescued every blind boy from the burning building and placed them on board the steamer.

Fifteen Years Paying Off \$25

LOAN SHARK EXTORTS \$500 ON NOTE FOR ONE-TWENTIETH OF THAT SUM.

CHICAGO, Dec. 12.—Fifteen years ago Mrs. John Murphy borrowed \$25 from a loan shark, to settle a debt that her boy had incurred secretly, contrary to his father's command. The note has just been canceled, through the interference of the Chicago Legal Aid society.

In the 15 years during which the loan shark has been nursing along the note, Mrs. Murphy has paid on it more than \$500—20 times the original loan. She paid interest at the rate of 10 per cent per month, 120 per cent per year. Whenever she got the note nearly paid off the shark would bully her into a renewal. She did this many times—signing the new notes with her mark, for she can neither read nor write.

Finally the loan shark died and his son came to collect. Less circumspect than his father, he came when the son, John Murphy, Jr., was at home. The latter heard the collector bullying his mother about a debt that he had thought settled a decade or more ago. He chased the man from the house.

HERE'S A BOY BANDIT

TACOMA, Dec. 12.—After holding up seven in six nights, the boy bandit last night, with a companion, stopped a street car conductor, Herman Crowl, at 17th and K sts. The bandit's gun discharged, the bullet hitting Crowl's cash holder and flattening out. Crowl's ticket punch in the face of the thieves, and they ran.

MORGAN BUYS ART

NEW YORK, Dec. 12.—It was news in art circles today that King Alfonso of Spain recently disposed of five celebrated rose Durrani gobelin tapestries depicting scenes from the story of "Don Quixote." Rumors have it that J. P. Morgan acquired the treasures.

Charges Against Wife

PITTSBURG, Dec. 12.—Andrew W. Mellon, multimillionaire banker, who is suing his wife, Mrs. Nora McMullen Mellon, member of a leading family of Dublin, Ireland, for a divorce, charging infidelity, and naming Capt. Alfred George Curphey of the English army as co-respondent, now accuses her of further instances of wrongdoing with Capt. Curphey in London and Buffalo during 1909. The new charges are contained in a rule on his wife to show cause why he should not amend his divorce libel, and why he should not oppose her application for a jury trial.

Mrs. Falster was badly hurt in an accident at Martins a few weeks ago, and her physicians fear that she cannot recover.

Underwood Not Running

WASHINGTON, Dec. 12.—Oscar W. Underwood of Alabama, majority leader of the house, was endorsed as a candidate for the democratic nomination by the Alabama delegation in congress. A resolution was adopted declaring that Underwood had "demonstrated to the country that he is a wise and progressive leader, and that he is eminently qualified for the presidency."
