### German Foreign Minister Says Landing of Troops by Allies in Greece Is Worse Than Germany's Opening Blow.

BERLIN, Oct. 13.—The world's storm of indignation against Germany for invading Belgium is "cant or schwindel," declared Foreign Minister Von Jagow, in an interview given to the United Press today, concerning the action of the allies in landing troops at Salonika.

I asked the foreign office if the chancellor would give out Germany's position on the landing. The foreign secretary received me, the chancellor being absent.

It was my impression that the people believe that not only has the cause for England's entrance into the war been removed by the landing in Greece, but the reason for the allies' reported prolonging of the war has also been removed.

Compares Situations  
 Von Jagow's statement regarding the Salonika landing was: "The English papers are taking the greatest pains to demonstrate that there is not the least analogy between Germany's entry of Belgium and the landing of English and French troops at Salonika under Gen. Hamilton."

"They emphasize the point that the Greek government and parliament forewent the right to protest against the procedure, that the allies never had in view any action upon Greek territory which would be unwelcome to Greece.

"The latest assertion is inaccurate, for the Greek government protested against the landing.

"If Greece refrained from resisting by armed force, that does not mitigate England's and France's blame.

"Certainly the violation of neutrality of Belgium by Germany and that of Greece by England and France cannot be compared, for in the first instance the question resolves itself about the threatening French advance thru Belgium against the resistance of the German empire.

"The landing of entente troops at Salonika was not founded on any such distressing emergency. It was based entirely upon the ground of political and military opportunity."

### England Answers Charge of Berlin Foreign Minister

LONDON, Oct. 13.—Answering the United Press interview with Herr Von Jagow, in which the German foreign minister denounced the allies for landing troops on Greek soil, a statement from a British official source was given today, asserting that "at no time have the allies taken action in Greek territory that would be unwelcome to Greece, and going into questions of neutrality, which promise to figure finally as the big issues of the war."

"The German government maintains that the dispatch of allied troops to Salonika is on a par with German violation of Belgian neutrality," says the statement, in part. "Germany was solemnly pledged, together with the other powers, to respect the neutrality of Belgium."

"Belgium had not agreed with the allied powers, either to attack Germany or to allow passage of allied troops.

"The Germans attempt to justify their action on the ground that the French were on the point of attacking them thru Belgium. This was totally untrue.

"In the case of Greece there is no question of violation of treaty obligations.

## \$200,000 MUST GO IN LEVY

Will Mayor Gill and the council majority be compelled to give in to the council majority on at least one of the converted items in the tax levy?

This appeared to be the case Wednesday.

The item in question is the \$200,000 due in July on a five-year serial bond issue.

Mayor Gill and the council majority have taken the position that this debt can be paid some other way, as, for example, issuing new bonds with which to pay the old one. The council majority on the other hand wants the debt definitely settled by levying \$200,000 in next year's taxes, instead of remaining in debt.

Wednesday morning, Council Clerk Shrader brought attention to a provision of the state laws, Section 421, Article 97, to this effect:

"The corporate authorities of a city, town or county SHALL provide annually by ordinance or resolution for the levy and extension on the tax rolls of such county, city or town, and for the collection thereof, of a direct annual tax in addition to all other taxes, WHICH SHALL BE SUFFICIENT TO MEET THE INTEREST ON ALL SAID BONDS PROMPTLY AS THE SAME MATURE AND ALSO SUFFICIENT TO FULLY PAY EACH SERIES OF BONDS AS THE SAME MATURES."

It is Schrader's opinion that this law compels the city to include in the tax levy the \$200,000 for taking up the bond payment due in July.

Councilman Hanna, who had voted against including this amount in the levy, is inclined to change his mind on this item, it is reported.
