NOTED AUSTRALIAN VISITS HERE; SAYS ALLIES CONFIDENT

On his way home from diplomatic conferences in England and France, and visits to the western battle fronts, P. McM. Glynn, former Australian minister of external affairs, and now member of the king's council and the federal war committee, was in Seattle Monday.

With his wife and children, he came from Vancouver to spend a day seeing the city, and was taken for an automobile tour as guest of Mayor Gill, on whom he called.

Citizen Training

"Australia has sent more than 250,000 troops to Europe," he said. "On the day war broke out, I was minister of external affairs, and telegraphed that we had 20,000 troops immediately available.

"Our system of citizen training made it possible for us to supply able troops steadily. We pay our troops well—six shillings (about \$1.50) a day.

England Confident

"There is now a feeling of calm confidence among English leaders. We feel that we are for the first time on an equal basis materially with the enemy.

"We do not underestimate the resourcefulness and the ability of the Germans to keep supplied with munitions and food for a long time to come, however.

"At last we have been able to assume the offensive, which will be a great factor for developing our armies. Whether or not Germany

SQUIRE "HET UP" AT G. O. P. MEET

Justice Reeves Aylmore Peevish When J. Y. C. Kellogg Is Named Secretary

HORR CHAIRMAN AGAIN

Squire Reeves Aylmore, who is, by way of identification, the justice of the peace of Mercer Island, threw several fits and a few tons of excitement Saturday afternoon at the Press club, where the republican precinct committeemen gathered to choose their officers.

The justice was riled a heap—a considerable heap, by heck—when someone proposed James Y. C. Kellogg for secretary of the county committee. It almost blinded Justice Aylmore to even think of it with his eyes closed.

He jumped plumb in the middle of the excitement of the moment, did the squire. He shook his head and he pointed his fingers. His blood boiled and his tongue waxed warmly eloquent.

"He's not a republican," Squire Aylmore charged against Kellogg. "Look! See!"

And the justice drew forth newspaper clippings which he read. They showed that Kellogg believed in non-partisanship in county and state elections.

"Therefore," the squire concluded, "he is not a republican."

Some hissed the "judge." Other applauded.

Kellogg replied to the attack, showed he was a republican, even though he did advocate nonpartisan-ship.

And when the vote was taken, Kellogg was elected secretary by vote of 129 to 115 against M. L. Berkhardt.

Kellogg was former chairman of the King county progressive committee.

Ralph M. Horr was re-elected chairman of the county committee as the result of a split vote against him. Horr received 145 votes, Frank Paul 141 and Fred Harper 27.

The election of chairman and secretary was accompanied by considerable noise and oratorical fireworks. The other officers were elected without opposition. W. G. Potts was re-elected state committeeman. George Grant was chosen vice chairman and John Metcalf treasurer.

MORE KILLED BY AUTO THAN ZEPS

Statistics Show 1,040 Victims in U. S. Since First of January

NEW YORK, Sept. 25.—More people have been killed and injured by automobiles on the streets of American cities during this year than in all the Zeppelin raids on England, Chicago and New York lead in the number of deaths, with more than 200 each between Jan. 1 and Sept. 1. The number of fatalities in other large cities is proportionately high, varying with the population of the towns. In Seattle there were eight killed.

These figures, compiled today, on reports from a score of cities are based upon police records, which show a constantly growing death list as a result of automobile accidents, despite improved traffic laws that have been enacted.

1,040 Killed

In the cities from which reports were available today, figures up to Sept. 1 show that a total of 1,040 persons have been killed and more than 5,000 injured. Only partial lists of injured were received, and it is possible the complete total would show almost double this number.

In Zeppelin raids on England to date, about 368 have been killed and 870 wounded in two years.

Police reports show 253 persons killed and 4,484 injured on the streets of New York up to Sept. 1. Chicago shows 205 killed, while Philadelphia reports 80. In Detroit, 63 were killed and 2,715 injured up to Sept. 1. Los Angeles reports 57 killed and Columbus, O., 40.

Traffic Rules

Practically all cities now have strict traffic rules "safety zones" for persons boarding street cars, and speed laws. Reports of fatalities and injuries in cities other than those already mentioned, follow:

San Francisco, 38 killed; St. Louis, 37; Cleveland, 20; state of Iowa, 29 and 409 injured; Des Moines, 15 killed; Denver, 26 killed; 524 injured; Milwaukee, 21 killed; Washington, 19; Portland and Seattle, 8 each; St. Paul and Minneapolis, 7; Dallas, 5 killed; 27 injured; Topeka, Kan., 5; Kansas City, 5 killed.

Horse Stands on Hind Legs 2 Days

NEW YORK, Sept. 25.—With block and tackle, searchers for a horse thought to be stolen hauled him from a well 12 feet deep off the Boston Post road, near Larchmont. The horse, belonging to the Owens Coal Co., has been standing on his hind legs two days in the shaft, which is only five feet wide, with three feet of water about his body.

The horse's neighing drew the searchers to the adjoining farm of James S. Neville, from which he had been missed. He had backed into the well and stuck in his strained position. He was luckily hungry when released and showed no injuries in a veterinary's examination.

JUDGES FIGHT FOR JOB ORDER

Represented by Charles Winders, attorney for the Northern Pacific Railway Co., and Otto Rupp, attorney for the Pacific Telephone Co., Judges Frater, Dykeman and Mackintosh Monday urged their claim before Justice French, of Kitsap county, for a certificate of election at the recent primaries.

They contend they received a majority of all the votes cast, and that therefore they were not merely nominated, but elected. Under their claim, their names are to appear separately on the November ballot, with no opponents to contest their places.

The suit is in the nature of mandamus proceedings to compel Auditor Phelps to issue election certificates to them. The claims of the three judges are contested by attorneys Charles Gleason, W. D. Lane and Edward Tule, nominees for the superior court, who appear in behalf of James McCabe, a candidate for judge who would be deprived of a nomination if Judges Frater, Dykeman and Mackintosh are declared elected.

The case was continued to Monday afternoon.

\$20,000 SHORTAGE IN FRISCO CONCERN

SAN FRANCISCO, Sept. 25.—Local officials of the Remington Typewriter Co. today began an investigation into a shortage of about \$20,000 in the firm's accounts.

John M. Lund, manager, has referred the entire matter to the Remington company's general offices in New York. The cashier of the local branch two weeks ago resigned his position when a shortage of \$200 was discovered. Since then the investigation has been conducted secretly.

College Romance Ends in Suicide

CHICAGO, Sept. 25.—A college romance turned to tragedy for the daughter of Dr. Ludvig Hektoen, famous pathologist at the University of Chicago, who was found dead last night with her infant daughter at Madison, Wis.

As Miss Allyn Hektoen, she was secretly married to Arthur A. Gelatt, of Madison, son of a wealthy publisher. They left on a trip to Europe just after graduation from the University of Wisconsin. They had not been living together for some time, notes found near the bodies indicated. The suicide occurred about a week ago, but was not discovered until last night.

ENLISTED MAN WINS CHOICE ARMY PLUM

SAN FRANCISCO, Sept. 25.—The appointment of Capt. Dennis B. Quinlan to the legal corps of the army with the rank of major, announced today, is perhaps the first instance where an enlisted man has risen to such a rank. Quinlan enlisted in the regular army at the outbreak of the Spanish-American war. He was an attorney before that time, and he has steadily gained promotion, being at present acting judge-advocate first instance in the Third division. Quinlan once won the army pistol championship.

RAID TWO GAMBLING HOUSES; ARREST 17

Police raided two gambling places Saturday night and Sunday, and in both cases made several arrests and confiscated considerable equipment.

At the Tourist hotel, Occidental ave. and Main st., the police made 17 arrests and smashed the furniture. Three Chinese were charged with running the game. The second raid was made on a suite in the Crown block at Second ave. and James st. Five men were arrested. C. H. Campbell was charged with running the game, while the remaining four were booked for gambling.

COMMERCIAL CLUB MEN TO MEET OCT. 5

The longed-for land problem will be one of the most important topics to be taken up in the two-day session of the Washington Federation of Commercial Organizations to be held at Anacortes October 5 and 6. Several matters that probably will come up before the legislature also will be taken up.

Among the speakers will be President Suzzallo, of the U. of W.; Secretary of State I. M. Howell; Assistant Highway Commissioner George F. Cotterill; H. W. Childs, deputy commissioner of publicity; Dr. Benson, of the U. of W.; and Dr. Cardiff, of the state college.

The Seattle Commercial Club will have an representative delegation at the conference.

BERLIN, Sept. 25.—A Zeppelin has again bombarded the fortification of Bucharest, capital of Rumania, it was officially announced today.

HEAD OF REALTY CO. IS OUT ON BAIL

William J. Bruggemann, president of the Central Realty Co., builder of Mrs. Ida L. Carstens' Lutzeria apartments, was arrested on a warrant issued by Deputy Prosecutor Ellis Saturday, charging him with the robbery of \$418.83 contained in the recent contractor's scandal, in which it developed that more than \$40,000 had been added to the original contract cost of the building.

Bruggemann was released on \$5,000 bail. This is the third arrest made in connection with the affair.

Charles Drake, building superintendent, is still in jail. He was arrested for failure to account for \$375 alleged to have been paid him for building purposes. Earl Baumgartner, timekeeper, is the third one held.

The books and valuable papers of the Realty Co. are being held by the county for evidence.
