Government Addresses Strikers. Salt Lake, Sept. 20.—Governor Spry's trip to Bingham was the sequence of a long conference between state officials, the county sheriff, commander of the state militia and representatives of the miners and mining companies.

Reports made by Adjutant General Wedgewood of the Utah National Guard, had indicated that in an emergency 400 men and a battery of artillery could be mustered for strike duty within eight hours.

News of the governor's start flashed to Bingham causing the postponement of preparations made by Chief Deputy Sheriff Axel Steele, for a flank attack on the miners' entrenchments.

The party which reached Bingham with the governor consisted of Chief Justice Frick of the supreme court, Attorney General Barnes and John Dern, members of the conciliation board; General Wedgewood, N. P. Stathakos, a well known Greek banker of Salt Lake, a priest of the Greek Catholic church, Warden Arthur Pratt of the state penitentiary, Charles H. Moyer, president of the Western Federation of Miners, and Lieutenant W. S. Persons, U. S. A., detailed as instructor to the national guard.

Strikers and citizens in numbers thronged about the party and there was no difficulty in collecting an audience for Governor Spry, who was the first speaker. He assured the miners that their right to quit work was unquestionable and then warned them not to interfere with property or violate the law.

The Rev. Lambrigos then addressed the Greek members of the crowd in their own tongue.

The governor was joined by Mr. Moyer and General Wedgewood and retired to a house where a discussion of the situation was resumed. Arguments of the officials were for time
