

DUBOIS PLACED OUT OF RUNNING BY GOV. HAWLEY

Announces He Will Not Appoint Former Senator to Fill Vacancy Caused by Heyburn's Death.

The attention of ex-United States Senator Fred T. Dubois was today called to the editorial appearing in the Salt Lake Tribune, virtually launching a boom for him for the recess senatorial appointment and in reply to it and the possibility of receiving the appointment, he said:

"I refer you to an interview which Governor Hawley gave out at Prater, Idaho, and which was printed in the Salt Lake Herald with an editorial in the same paper on Sunday. Governor Hawley seems to have answered your question."

In his Prater interview Governor Hawley declared he had no intention of appointing ex-United States Senator Fred T. Dubois to the senatorial vacancy. Commenting on this interview the Herald says in part editorially:

"The definite announcement by the governor of Idaho that he has no intention of appointing Fred T. Dubois to the senatorial vacancy occasioned by the death of Mr. Heyburn will be good news to the people of the intermountain states. The fear that this would be done, however, was justified because of the friendship between Governor Hawley and Dubois and the prominent part the latter has once more assumed in controlling Democratic politics in the Gem state. The important role which Dubois played as western manager of the pre-convention campaign for Speaker Clark loaned him a rather doubtful and temporary political respectability and he has used this to advantage in forcing himself once more upon his party in the state that had fondly imagined it was rid of him for good and all."

The Tribune's editorial follows: "The death of Senator Heyburn leaves a vacancy in a senatorship from Idaho. Governor Hawley of that state will have the appointment of the senator to succeed Mr. Heyburn until the election of a successor by the Idaho legislature."

"Accordingly, there is already a good deal of speculation as to whom Governor Hawley may appoint. His appointee will be a Democrat, of course, since he is himself a Democrat. There is, then, as it seems to us, but one appointment that the Governor can make that will be fully warranted in every respect and will shed the greatest amount of luster upon the state of Idaho, and put in the senatorial seat a man who will not need to win his spurs, but who already enjoys national fame and high political repute in the minds of all the leading Democrats of the nation as well as his enjoying large acquaintance and respect in the senate itself."

"We refer to the Hon. Fred T. Dubois, who has heretofore served two full terms in the United States senate from Idaho, having been one of the first senators from that state, 1891-1897, re-elected for the term from 1901 to 1907. He has been prominent in Democratic party work for many years, and made a great name as a successful political manager by carrying Speaker Champ Clark's candidacy for president of the United States almost to the point of success in the Baltimore convention of last June. But for the wholly unexpected and sensational attack upon Mr. Clark by Mr. Bryan, there seems little doubt that Speaker Clark would have been nominated in place of Governor Wilson. But that in no wise diminishes the high prestige which Mr. Dubois attained as a great party worker and effective campaign manager."

"The appointment of Mr. Dubois, therefore, would be a just recognition of Mr. Dubois' high record, and his present lofty standing among the great men of his party. Governor Hawley has the opportunity now of giving to Idaho, for the present at least, the highest possible standing through the appointment of Mr. Dubois to the vacant senatorship, and the Tribune hopes that he will take advantage of this opportunity, because the appointment of Mr. Dubois would give the state the highest possible prestige, and it would be a fit recognition of the great services of Idaho's most prominent Democratic citizen. No other appointment could possibly rank so high as this, and the Tribune fully believes that Governor Hawley will see it in the same light that we do, and will give his state the benefit accordingly of the high standing, the lofty prestige and the eminent record of Mr. Dubois by giving him this appointment. THINKS WILSON WILL CARRY ALL BUT FIVE STATES

Ex-Senator Dubois Concedes One State to Roosevelt and Two Taft, While Two Others Are Doubtful.

Placing Theodore Roosevelt third in the race for the presidency, giving him but the state of South Dakota, conceding but two states to President Taft, or Utah and Wyoming, predicting close contests in Idaho and Vermont between Taft and Wilson, and giving every other state in the union to Woodrow Wilson, Democratic candidate for president, who he believes has the best chance to carry them, ex-United States Senator Fred T. Dubois, manager of Champ Clark's pre-convention presidential boom, today broke a long silence and in an interview given to the Capital News made clear his attitude in his loyal support to Woodrow Wilson, his voluntary efforts in his behalf, and his view of the present political situation.

Dubois Wrote Many Letters. "The Wilson managers are very anxious that the Clark supporters give Governor Wilson their cordial support, and I wrote some 20,000 letters to leading Clark men throughout the United States, receiving thousands of replies, and some of the men who were in my headquarters during the pre-convention campaign are now in the national headquarters in New York looking especially after the Clark supporters throughout the United States."

"Since writing these first 20,000 letters something like 10,000 more letters have gone out under my supervision to the Clark supporters. The answers to the letters were carefully read and some of them sent to the headquarters in Chicago, especially those appertaining to the western country. Assumed Responsibility, Loyal to Party. "Speaker Clark himself is making speeches for Governor Wilson and he has sent out some thousands of letters to his supporters for the nomination. "I have not been located in the New York or Chicago headquarters, but in the manner indicated above have assumed the responsibility of trying to put the supporters of Speaker Clark throughout the United States in perfect accord and harmony with Governor Wilson and the managers of Governor Wilson's campaign."

"This has fully occupied my time and I am intensely satisfied with the results of my efforts. I accepted this responsibility on so large a scale at the most urgent and earnest solicitation of the managers of Governor Wilson's national campaign. Senator Gore placed my Iowa manager, Mr. Jamison, in charge of the organization work and one of my confidential men at the Clark headquarters in the pre-convention fight is directly under Mr. Jamison and the national headquarters is especially looking after correspondence with the supporters of Speaker Clark."

"I think the supporters of Speaker Clark are earnestly supporting Governor Wilson. There is scarcely a defection among Speaker Clark's friends. The result of this is that the Democratic party is united and harmonious throughout the United States and the election of Governor Wilson is assured. Gives His Forecast. "With a united Democracy and a Republican party divided into two equal parts, Governor Wilson will have the largest majority in the electoral college which any president has received since Monroe."

"My guess as to the presidential contest would be this: Roosevelt will carry South Dakota, Taft will carry Utah and Wyoming, the contest in Idaho will be close between Wilson and Taft, the contest in Vermont will be close between Wilson and Taft, and Wilson has the best chance to carry every other state in the union and I would not be at all surprised if he did so. "The vote between Taft and Roosevelt will be very close in a good many states, but Roosevelt will be third in the race."

Ex-Senator Dubois said he expects to remain here until tomorrow night, when he will leave for the northern part of the state looking after the interests of Governor Wilson, and conferring with his political friends and party leaders there. He was a conspicuous figure today around Democratic headquarters, where he held consultations with many party leaders and State Chairman Gray. He said that he will also go on the same mission that has brought him to Boise—the interests of Governor Wilson—into Washington, Montana and possibly Utah.
