

SATURDAY GAME TO BE DECISIVE

Minnesota and Wisconsin to Struggle for the Western Championship.

Chicago, Nov. 15.—With the end of the conference football season one week away, Saturday's game at Minneapolis between the University of Wisconsin and the University of Minnesota is expected to settle the conference championship. If Wisconsin wins the championship will go to Madison. If Minnesota wins the twins will have Chicago to play on Nov. 23 in the last game of the season.

University of Chicago coaches and backers, however do not predict that the Maroon team can hope to do more than make a fair showing against Minnesota.

If Minnesota should win and at such a cost in crippled players that Chicago could defeat the team a week from Saturday, the conference championship would be lost in a triple tie, with each of the leading teams having one defeat to its record. This possibility is not considered seriously by football experts and Saturday's game is looked on as the championship battle. The other teams of the conference have been decisively defeated and are out of this year's race.

Wisconsin's backers insist that the powerful Cardinal team which has overwhelmed every opponent this year, cannot lose to Minnesota. Both Van Ripper, Wisconsin's star halfback, and Gillette have recovered from their injuries and will be in the game for which they have been saved.

Minnesota will be without the services of Erdahl, its crack halfback. The far north players, however, point to the fact that team has never been in danger of losing a game this year and assert that the men from Wisconsin will fare no better than the teams that have preceded them. The game promises to be one of the hardest contests ever staged in the conference and interest in it is intense throughout the "big nine."

Chicago and Illinois play Saturday at Urbana, probably for third honors. Indiana and Northwestern have no games scheduled. Iowa plays the Iowa Aggies at Ames for the state championship and Ohio State plays Pennsylvania State at Columbus.

SLOSSON GIVES GREAT BILLIARD EXHIBITION

New York, Nov. 15.—The best exhibition thus far of the professional 15.2 ball line billiard tournament was given last night by George Slosson, the veteran player, in his match with Demarest, whom he defeated 500 to 228.

Slosson's play was that of a master and his nursing and delicate cue work netted him the high average and high run of the tournament up to the present, as he made 156 in his ninth inning. Three innings later he ran 133. Demarest's best efforts were 44 and 26, and at no time did the young Chicago player appear able to do himself justice.
