BANK DEPOSITS AT GREAT INDUSTRIAL CALDWELL BIGGEST PARADE FEATURE AT IN CITY'S HISTORY NAMPA'S FESTIVAL

Condition Attributed to the Prosperity of Farmers of the Country Surrounding County Seat.

Caldwell, Sept. 19.—Bank deposits in this city at the present time amount to approximately \$2,500,000 and clearly reflect the wonderful prosperity which is featuring this city and the surrounding country upon which it draws for its business life. The ready circulation of money is to be very largely attributed to the phenomenal prosperity which is being enjoyed by the farmers of the various tributary communities who are correlating their agricultural operations with the livestock industry to great profit. In fact these two industries may be said to constitute "the bootstrap" by which this city and surrounding communities have pulled themselves up within the last few years from a common place condition to their eminently satisfactory financial condition of the present.

One of the impressive conditions to be observed in most any of the surrounding communities is that automobiles are owned by the great majority of its farmers, and the farmer who does not own an automobile is indeed an exception to the rule in his neighborhood. Agriculture and the livestock industry constitute the real basis of the prosperity of Canyon county, and in no place within its boundaries is the profitability of these industries more manifest than in this city.

GUILTY OF BOOTLEGGING.
Caldwell, Sept. 19.—In the district court today Juan Bernemsole of Nampa, charged with having violated the statewide prohibition law in January by selling a quart of whisky to Walter Gibbs, then on the detective force of that city, was convicted. The trial of the case was completed at noon and the case immediately given to the jury, which reported its verdict within a few minutes. Bernemsole is to appear before Judge Bryan for sentence Friday morning.

Drill by B Company of the Second Idaho Infantry Witnessed by Big Crowd—Good Exhibits.

Nampa, Sept. 19.—With an increased attendance over the two preceding days, the third day of the annual harvest festival now in progress in this city was celebrated today. The initial feature of the program of the day was the big industrial parade at 10 o'clock this morning, in which the various industries of the city were represented, and which reflected in no small measure the progress of the city and its importance along industrial lines. One of the highly interesting features of today's program was the drill of company B of the Second Idaho which was witnessed by several thousand citizens of this city, its neighboring interurban cities and towns and tributary communities. The young men of company B were accompanied by the regimental band which provided inspiring patriotic music for the day. More than 175 of the soldier boys were in the special cars which arrived in the city from the Boise barracks at 2 o'clock, and throughout the day they were the recipients of the most considerate attention. Their presence and participation in the program of the day added very greatly to its importance.

EXCELLENT EXHIBITS.
In the livestock, agricultural and horticultural exhibits which are admirably arranged all of the communities of Canyon county are well represented, and these exhibits are of such excellence as to be a wonderful revelation of potentialities for future development, possessed by these industries. In fact they establish beyond controversy that Canyon county is second to none in the state and equal to any section of neighboring states in adaptability for these industries which have constituted the real basis of the country's wonderful progress and phenomenal prosperity, and which will continue to do so. Today was designated "Caldwell day" and hundred

reds of citizens from "the Magic city" were in attendance and participated in the festivities of the day. Tomorrow will be "Boise day" and it is anticipated that there will be a remarkably large attendance from the capital city. The mammoth livestock parade will be one of the features of the early part of tomorrow's program and it will be participated in by purebred and thoroughbred livestock breeders from all sections of Canyon, Ada and Washington counties, and will be well calculated to excite the admiration of all lovers of fine stock.

JUDGING BEGUN.
Particularly attractive are the farm exhibits from Kuna, Bowmont, the South Side Boulevard Grange and Eagle Heights. The horticultural exhibits of the Stephens Orchard company occupy an extensive booth and have excited much favorable comment. Official judging in all departments except that of livestock was commenced today. The horses will be judged tomorrow and cattle and sheep Friday.

FREEMAN TAKEN TO HOSPITAL AT BOISE

Caldwell, Sept. 19.—George Freeman, who was shot last Saturday evening by Frank Brim, a 16-year-old lad of this city, while defending himself from Freeman and Frank Lohby, both of whom were intoxicated, was taken to Boise hospital for medical treatment today. For the past three days but little hope has been entertained for Freeman's recovery, but within recent hours he is so greatly improved as to justify the possibility that he will recover. One of the shots from the lad's pistol lodged just above his heart and paralysis of the body below this point ensued.
