STATE NEWS

Carl J. Erickson died at his home in Kippen, Idaho, on November 9th of heart trouble after an illness of three weeks. Deceased was born in Dakota in 1876.

Work began on Monday at Florence on the Banner properties, a large force of men being engaged in moving the heavy machinery from the old Blossom mine over to the Banner. There is also 400 cords of wood to be moved.—Standard.

Articles of incorporation of the Bank of Sand Point have been filed with the secretary of state, with capital stock of \$25,000. The directors selected are: J. A. Humbird, of St. Paul, Minn., A. E. Rickerd, Henry S. Lee, W. A. Haws, Charles L. Helman, all of Sand Point.

There is a wonderful piece of ore from Thunder Mountain at the First National bank. It weighs about 100 pounds and is so valuable that it is placed in the vault at night for safety. One face of the piece, presenting an irregular surface approximately 14 inches square, is literally plastered with gold—not sprinkled with the metal but covered completely as heavy frost covers a plank.—Lewiston Teller.

Another sale of a well-known mine was consummated Monday by Capt. John Wood, representing Chicago people. It was for the transfer of the Blue Jacket mine near Crooks Corral. The sale was effected by telegraph, and calls for the payment of the entire purchase price in 30 days. This is the property which Finch & Campbell abandoned last spring and upon which Frank Johnness has worked so faithfully and successfully.—Free Press.

Five carloads of flax were shipped from here Wednesday evening. This makes in the neighborhood of forty cars since the 1st of the month, with an average of 900 bushels to the car, which at the rate of \$1.20 per bushel would amount to \$48,200. There is still a large amount of flax stored here and the grain men are anxious to obtain cars so that they can ship it out. There were six empties brought in Wednesday evening which will be loaded and shipped out Saturday night.—Cbl. de Sac Register.

L. A. Porter shipped out six carloads of winter apples and two carloads of prunes from here Sunday, two carloads of apples Monday and two or three carloads more during the week, all destined for eastern and southern points, some as far south as Fort Worth, Tex., and as far east as Rochester, N. Y. He has between 20 and 25 carloads in the cold storage which will be shipped later in the season. The picking of apples in the big Clemens orchard on the Potlatch was completed Wednesday and the packing of the same yesterday. This orchard yielded about 12,000 boxes.—Kendrick Gazette.

Dewey, of Idaho, has created a sensation in Chicago relative to the mineral resources of the silver state, and more particularly as to the wonderful gold deposits which he has recently discovered. According to an interview recently published in the Chicago Record-Herald the colonel stands a chance of becoming a second Monte Christo. The article is as follows: "Colonel W. H. Dewey of Idaho believes he is the richest man in the world or that he soon will be. There will be trumpet tidings from Idaho within two or three months, he says, tidings that will proclaim Idaho an American Transvaal or a United States Klondike, that will pale the fame of Cripple Creek or any other old diggings. The colonel carries in his pocket a vaseline bottle filled with pure gold, all extracted from just three pounds of quartz. He knows a man who made a bet that a pound of rock from the new Idaho field would result in from \$60 to \$80 worth of gold."

ORDINANCE NO. 6.

An ordinance prescribing the manner of building sidewalks and crosswalks in the Village of Cottonwood.

Be it ordained by the Chairman and Board of Trustees of the Village of Cottonwood:
 Section 1. That all sidewalks on 60, 80 and 100 foot streets to be not less than six feet wide nor wider than eight feet. Six foot sidewalks to have four stringers not less than 2x6, and 8 foot walks to have five stringers. Stringers to be covered with timber not less than 1 1/2 inches thick and 6 inches wide, nor larger than 2 inches thick and 12 inches wide, and must be built in a workmanlike manner.
 Section 2. That no sidewalk be accepted by the Board of Village Trustees until same is inspected by the marshal.
 Section 3. Cross walks to be built of lumber not less than 3 inches thick with cross stringers 4x4 not more than 3 feet apart, and crosswalks shall be not less than 3 feet wide on top.
 Section 4. This ordinance shall be in force from and after its passage and publication.
